8. PUBLIC QUESTION PERIOD - 15 Minute Limit (5 Minutes per Speaker)

8.1. Emily Daigle, Ward 3 Resident spoke regarding Item 17.4., a by-law to amend By-law 0555-200, as amended, being the Traffic By-law with respect to parking on Caterpillar Road, Ward 1 and noted that the implementation of sidewalks would be helpful for Residents with mobility issues, as the courier pick-up location is on the street. Additionally Ms. Daigle spoke to lower boulevard parking and commented on the challenges incurred by Residents with mobility issues if the home-owner is not in compliance with the by-law.

Councillor Fonseca provided direction to staff to investigate and include in a parking study the use of a complaint-based process. Additionally, staff was requested to investigate the installation of sidewalks on Caterpillar Road. Geoff Wright, Commissioner of Transportation and Works indicated that he would direct the comments back to staff to look at possible implementation of the sidewalk program and the installation of interim measures.

The Mayor and Members of Council engaged in discussion on this matter and noted agreement in passing the motion at Mississauga Council prior to bringing it forward at the Regional Council meeting on April 11, 2019.

WHEREAS the Province of Ontario established a Regional Governance model in 1974 for selected municipalities, but not all, as a means of regulating growth as well as providing cost savings through economies of scale; and

WHEREAS under this system the three municipalities that make up the Region of Peel have experienced varying degrees of growth, with Mississauga currently achieving "built out status" with a population approaching 800,000, making it the third largest city in Ontario and sixth in Canada; and

WHEREAS Mississauga has the financial and administrative capacity to govern its own affairs, as well as a jobs to population ratio that ensures a thriving, selfsufficient economy will continue well into the future; and

WHEREAS the current provincial government is currently reviewing regional governance with an eye to introducing possible changes; and

WHEREAS the City of Mississauga Council has unanimously supported, in principle, a resolution to make Mississauga an independent, single-tier and self-sufficient City - similar to two larger and many smaller municipalities across Ontario; and

WHEREAS the Regional Chair and the senior staff derive their authority solely from twenty-four elected representatives from all three municipalities that make up the Council of the Region of Peel; and

WHEREAS through a variety of actions not approved nor shared with all 24 members of Peel Council, the Chair and senior staff have formulated and put forward a position on behalf of Peel Council to the province's advisors on regional governance that is directly opposite to that of 50% of its members; and

WHEREAS the matter of regional governance and specifically the future of the Region of Peel, and its member municipalities, is of utmost importance at this time;

THEREFORE BE IT RESOLVED THAT:

- 1. The Regional Chair and staff cease all activities, studies and public statements related to the current Provincial Government Review; and further
- 2. The Chair and staff seek specific direction from Council in the matter of Peel's remaining a Region comprised of three municipalities, or any other configuration agreed to by Council, before any further comments verbal or written are made related to the subject of regional governance.

18. MATTERS PERTAINING TO REGION OF PEEL COUNCIL

- 18.1. Councillor Fonseca inquired as to what percentage of the gas tax the City of Mississauga has received over time and with what impact, to which Gary Kent, Commissioner of Corporate Services and Chief Financial Officer advised that Mississauga's share would be 18.8%. Councillor Parrish added that gas tax dollars are to go toward new projects only.
- 18.2. Councillor Carlson inquired about whether the Regional Chair has a vote, to which Mary Ellen Bench, City Solicitor advised that each Mayor has one vote at the Region and the Chair does not.

19. ENQUIRIES

19.1. Tree-Planting Program for Private Property

Councillor Ras noted that Toronto and York have tree-planting programs for private properties, inquired whether the City had explored that option and provided direction to staff to report back on the matter.

19.2. "No Trucks" Signs

Councillor Fonseca noted that several "no trucks" signs along Eastgate Parkway that had been taken down during construction, had not been replaced and provided direction to staff to investigate.

19.3. Intersection at Benson Road and Lakeshore Road, Ward 1

Councillor Dasko noted concerns with the intersection in front of the Compass in Ward 1 and inquired whether a set of lights could be installed at the intersection of Benson Road and Lakeshore Road. Geoff Wright, Commissioner of Transportation and Works indicated that staff would review the intersection and report back to the Councillor's Office.

19.4. Illegal Signs

Councillor Mahoney noted an increase of illegal signs being erected, to which Geoff Wright, Commissioner of Transportation and Works indicated that the Works Operations team would be doing a blitz to take these signs down and that he would get back to the Councillor with the details.

19.5. Open House Signs

Councillor Ras spoke regarding open house signs that are not taken down and indicated that she had asked staff to do a sign removal blitz in the area. Andrew Whittemore, Commissioner of Planning and Building indicated that a report would be going to Planning and Development Committee in the near future. Geoff Wright, Commissioner of Transportation and Works noted that he would send correspondence to the Members of Council regarding this issue.

19.6. MiWay Bus

Mayor Crombie advised that she had heard from a resident that a MiWay bus had a broken back door and inquired as to the process of getting it repaired, to which Geoff Wright, Commissioner of Transportation and Works explained the process.

19.7. Tailgating Legislation

Mayor Crombie spoke regarding tailgating and asked Paul Mitcham, Commissioner of Community Services to speak to the matter. Mr. Mitcham indicated that staff is waiting for the legislation and then will consider the City's options. Additionally, Mr. Mitcham spoke to the potential of increased costs due to increased security and serving alcohol.

20. OTHER BUSINESS/ANNOUNCEMENTS

20.1. Regional Governance/ City of Mississauga

Mayor Crombie spoke regarding the recent Town Hall meeting focused on regional governance and noted that Strategic Communications was putting together a communication plan. Discussion ensued with respect to the possibility of creating signs and Ward Town Hall meetings to gain resident feedback. Janice Baker, City Manager and Chief Administrative Officer indicated that there would be tweets and possibly a website and that staff could create a digital "sign" that residents could print and put up in their windows if they chose to. Furthermore, the Members of Council were invited to meet with staff and staff offered to attend the Ward Town Hall meetings.

AND WHEREAS The Collegeway G.P. Inc. appealed to LPAT (previously OMB) prior to Council making its decision, and the LPAT hearing is scheduled to commence April 25, 2019;

AND WHEREAS The Collegeway G.P. Inc. made a without prejudice settlement offer to the City dated April 1, 2019 (initially submitted in February of 2019 but then revised and newly submitted April 1, 2019) in regards to resolving the appeal to LPAT concerning its development application;

AND WHEREAS Council had considered the without prejudice settlement offer from The Collegeway G.P. Inc. and believes the settlement proposal does not address Council's concerns with the development proposal particularly, but not only, as regards the issue of unacceptable density as well as unacceptable built form;
