7. **DEPUTATIONS**

7.1. Homelessness and Lack of Affordable and Accessible Housing

Beverly Halls, resident, spoke to Council regarding the lack of affordable housing in Mississauga. Ms. Hall's deputation spoke to the following: homelessness in Mississauga and those it affects; unsafe basement apartments; designated areas in parks where

people can go; taxing landlords at a higher rate and using portion of tax for affordable housing; the City having a strategy office to assist residents and act as a co-signer for rental units.

Councillor Ras spoke to taxes relating to the Region of Peel noting that 1.5% of property taxes at the Region of Peel are set to address homelessness and housing. Councillor Ras also spoke to working with groups to formulate ideas to help address issues surrounding homelessness and affordable housing.

Councillor Parrish spoke to a report going to Region of Peel Council to approve more funding for affordable housing; outreach programs done by the Region of Peel; basement apartments in the City; and spoke to not supporting designated areas in parks for the homeless.

Councillor Damerla spoke to having more responsibility placed on the landlords to upkeep apartments.

Members of Council engaged in a discussion regarding all levels of government supporting and providing more funding for homelessness programs and affordable housing; co-operative housing; and Compass Food Bank and Outreach Centre.

Ninth Line and Mayfield in Urban Growth Boundary

Councillor Parrish spoke to a report at the Region of Peel regarding Ninth Line and Mayfield Road combining to be a part of the urban growth boundary.
