# 7. <u>DEPUTATIONS</u>

7.1 <u>2020 Budget (Item 12.1)</u>

Frank Stendardo, Chair, Mississauga Seniors Council spoke on the 2020 Budget and expressed his concern with the proposed tax increase being too high and unaffordable for seniors who are on a fixed income.

Members of Council raised questions regarding the deferral options, the eligibility criteria and benchmarking.

Gary Kent, Commissioner of Corporate Services & Chief Financial Officer and Connie Mesih, Director, Revenue & Materiel Management responded by noting the options the City and Province provide to receive financial assistance and/or defer property tax payments.

Direction to staff was given to design an outreach program and report back on all programs and options available to Council that includes benchmarking with other municipalities.

Ben Philips, Manager, Official Plan Review and Ruth Marland, Manager, Community Relations presented the three winning films from the Our Future City: Urban Film Forum and Short Film Competition;

#### 7.3 <u>2020-2023 Budget and Plan Additional Information (Item 12.1)</u>

Jeff Jackson, Director of Finance and Treasurer Jackson provided an update on the 2020-2023 Budget.

Members of Council spoke to the matter and raised the following questions and concerns:

- Concerned about utilizing the surplus to reduce the overall tax;
- Suggested reducing and/or deferring new initiatives;
- Inquired when the City knows what the surplus amount will be;
- Inquired whether the surplus goes into the capital or operating budget;
- Inquired about the Celebration Square Attendants;
- Inquired about the Planning and Zone Examiner position; and
- Inquired about the teaching kitchen in Meadowvale Community Centre.

Mr. Jackson, Janice Baker, City Manager and CAO, Geoff Wright, Commissioner of Transportation and Works and Andrew Whittemore Commissioner of Planning and Building responded to questions from the Members of Council.

Chris Mackie, MIRANET inquired about the budget surplus being allocated to a number of reserve accounts and inquired why the City of Brampton's budget is not included in the comparative chart. Janice Baker, City Manager and CAO responded by noting that the surplus is allocated to a number of specific reserves, however any excess is allocated to the capital budget. Jeff Jackson, Director Finance and Treasurer responded by noting that the City of Brampton's budget deliberations do not start until February.
