10. MATTERS PERTAINING TO COVID-19

Mayor Crombie spoke to the total number of COVID-19 cases in Mississauga and the Region of Peel, enforcement measures in the City and fines issued related to littering of personal protective equipment (PPE), fireworks and parking.

Mayor Crombie and Diana Rusnov, City Clerk and Director, Legislative Services, spoke to the letter received by Dr. Lawrence Loh, Interim Medical Officer, Region of Peel regarding recommendations for phase one reopening in the Region of Peel and Michelle DiEmanuele, CEO, Trillium Health regarding current capacity related to COVID-19. The letters were shared with Members of Council and read aloud.

10.1 <u>Jodi Robillos, Director of Parks, Forestry and Environment and Shari Lichterman,</u> Commissioner Community Services to present regarding the re-opening of parks

Jodi Robillos, Director of Parks, Forestry and Environment and Shari Lichterman, Commissioner Community Services provided an overview of the changes to provincial legislation allowing the reopening of park amenities and spoke to the following:

- The types of park amenities affected
- Input provided by Peel Public Health on the readiness of the Region re-opening
- Phased approached to reopening of facilities and park amenities

- Enforcement measures
- Updated information and messaging to the public

Items 10.2. and 10.3. was addressed at this time.

Mayor Crombie spoke the recommendations provided by Dr. Loh, Interim Medical Officer, Peel Public Health regarding the matrix that needs to be met in order for the City to reopen noting that the City has not seen a decline in new cases for 14 consecutive days. Mayor Crombie spoke to the letter, developing a phased approach to reopening City and noted the Mayor of Brampton also agreed it is too soon for the Region of Peel to reopen.

Members of Council engaged in a discussion regarding the provincial legislation allowing the reopening of park amenities and spoke to clear signage in parks; phased reopening of parking lots at parks and amenities; delays in reopening services and amenities and its effects on public compliance; support for the comments provided by Dr. Loh and Michelle DiEmanuele; and creating a phased reopening plan.

Councillor Parrish raised concerns with the increase in poverty noting that food banks in the area are overwhelmed.

Councillor Ras spoke to parking issues in Ward 2 noting that closed parking lots are causing the public to park on residential streets.

Councillor Dasko spoke to a large number of residents going to the lake and raised concerns regarding parking, signage and people removing barricades to access the Memorial Park.

Councillor Fonseca spoke to community gardens and whether camp programs could rent pool areas.

In response, Ms. Robillos noted that community gardens are closed to general programming and is only available to gardeners registered with the community garden. Ms. Robillos also noted that pool areas will remain closed until further notice and will not be available for camp programs to rent.

In response, Ms. Lichterman spoke to seeking direction from Council regarding how staff should proceed with reopening of park amenities and services.

Councillor Saito provided direction to staff to form criteria for reopening of park amenities and City services. Members of Council agreed to bring forward a motion directing staff to bring a report back to Council for a plan related to the reopening of phase 2 facilities and parks.

A video entitled "Thank you, Mississauga" featuring the City's former Poet Laureate Wali Shah, that captured the moments during the COVID-19 pandemic in Mississauga and a message of hope was shown to Members of Council
