#### 10. <u>MATTERS PERTAINING TO COVID-19</u>

Councillor Ras enquired about when the City would be revisiting parking enforcement. Geoff Wright, Commissioner, Transportation and Works advised that staff would bring a report to Council on resuming the parking enforcement program.

Members of Council raised concerns with vehicle noise and drag racing. Sam Rogers, Director, Enforcement advised that staff had been in consultation with Peel Regional Police on these issues and that staff would be bringing a report to Council on July 8, 2020 with respect to the noise control program.

Councillor Starr enquired about marriage license fees for couples whose marriage license had expired during the COVID-19 Pandemic. Diana Rusnov, Director, Legislative Services and City Clerk advised that staff were in consultation with the Registrar General regarding the fee to reissue a marriage license. Ms. Rusnov noted that at this time the City would be charging the minimum fee of \$75 and advised that if the Province provides direction to waive the fee the City would provide a refund.

Councillor Saito noted increased enquires from residents regarding property tax bills. Gary Kent, Commissioner, Corporate Services and CFO spoke to the current volume of calls and advised that finance staff had been redeployed to the 311 line in order to respond to the increased property tax enquiries.

Councillor Saito directed staff to prepare a motion for the Council meeting on June 24, 2020 to amend the Sign By-law to grant certain exceptions to businesses that erect portable signs during the COVID-19 Pandemic.

Councillor McFadden enquired about the availability of masks for firefighters. Tim Beckett, Fire Chief advised that staff had run out of their current supply of masks and that firefighters were currently using self-contained breathing apparatuses, as staff continue to explore viable options for obtaining a new supply of masks.

# 10.1 Repeal of the fireworks by-law 0108-2020 to lift the prohibition related to the sale and use of fireworks during the COVID-19 Emergency Period

Councillor Dasko enquired if shops within industrial complexes would be permitted to sell fireworks once the prohibition was lifted. Andra Maxwell, City Solicitor advised that the sale of fireworks would be permitted if shops have street front entrances.

#### **RESOLUTION 0189-2020**

That By-law 0108-2020 be repealed to lift the prohibition related to the sale and use of fireworks during the COVID-19 emergency period in accordance with the Corporate Report dated June 10, 2020 from the Commissioner of Community Services and that the said amendments be effective on the date of Council's approval.

#### 10.2 Community Services Verbal Update - Phase 2 of the Provincial Reopening Framework

Shari Lichterman, Commissioner, Community Services provided an update on the Community Services reopening plan under the Provincial reopening framework. Ms. Lichterman noted the parks amenities that were currently open and noted which parks amenities would reopen under the Province's Stage 1 recovery currently in effect for Peel Region. Ms. Lichterman also noted which parks amenities were recommended to reopen once the Peel Region enters Stage 2.

Members of Council spoke to the update and raised the following questions:

- Inquired about parking on School Board property;
- Inquired about weddings, funerals and religious gatherings;
- Inquired about the enforcement of sports play and the 10 person gatherings rule;
- Inquired about the deployment of parks ambassadors; and
- Concerns with littering in public spaces.

In response Jodi Robillos, Director, Parks, Forestry and Environment advised that the City has parking agreements with the School Boards to allow for residents to park on School Board property when using the City's parks amenities.

In response Andra Maxwell, City Solicitor advised that the Province would be allowing indoor wedding and funeral venues to operate at a maximum of 30 percent capacity and noted that outdoor ceremonies would be limited to 50 people.

In response Ms. Lichterman advised that the City would be following the Provincial Sports Organization's return to play program, which would be separate from the 10 person gatherings rule. Ms. Lichterman also noted that park ambassadors had been deployed regularly to major parks to educate on concerns related to physical distancing and littering.

#### 10.3 <u>City of Mississauga's Economic Resilience Task Force</u>

Councillor Damerla spoke to the proposed stakeholder engagement and the representation of small businesses most impacted by the COVID-19 Pandemic. Councillor Saito spoke to the membership selection of the task force and encouraged the involvement of all Members of Council. Mayor Crombie suggested that a website expert be included on the task force to help advise small businesses on website design and operations.

#### 10.4 COVID-19 Recovery – Support for Temporary Outdoor Patios

Items 10.4 and 16.1 were addressed together at this time.

Andrew Whittemore, Commissioner, Planning and Building spoke to the report and provided a summary of the recommendations. Mr. Whittemore noted that a report could be brought to Council with respect to outdoor patios if Members of Council direct staff to revisit the subject matter past the COVID-19 Pandemic.

Members of Council expressed their support and raised the following questions:

- Inquired about the impact on traffic and parking;
- Inquired about the process for restaurants in strip plazas to create outdoor patios; and
- Inquired about amplified sound in residential zones passed 5:00 PM.

In response Mr. Whittemore advised that Planning and Building staff were working with Transportation and Works staff to ensure all parking and traffic safety requirements are met. Mr. Whittemore also advised staff would be preparing a design brief to advise restaurant owners of the conditions for creating temporary outdoor patios.

In response Sam Rogers, Director, Enforcement advised that enforcement of the Noise Control By-law would continue and staff would work with Councillors on a case by-case basis to allow for exemptions to the Noise Control By-law.

  - i. the Prohibit Sale of Goods on Highways By-law 127-95 to temporarily permit business operations on a public highway;
  - ii. the Encroachment By-law 57-04 to allow temporary outdoor patios accessory to all types of restaurants to temporarily infringe on a public highway;
  - iii. the Business Licensing By-law 001-2006 to allow temporary outdoor patios on private property to comply with zoning requirements;
  - iv. the Fees and Charges By-law 0156-2019 to allow an application for a temporary outdoor patio to be processed without charge.
- 3. That Council direct staff, upon the issuance of notice for the statutory public meeting to consider the temporary use by-law, to suspend the enforcement of those zoning by-law provisions which currently prohibit or regulate outdoor patios accessory to all types of restaurants on private and public lands and that the suspension continue until the temporary use zoning by-law comes into force or until the duration stipulated for the temporary use zoning by-law expires, as may be the case.
- 4. Notwithstanding planning protocol, that a recommendation report from the Commissioner of Planning and Building be scheduled for a Planning and Development Committee meeting to be held on July 8, 2020, to conduct a public meeting to meet the statutory requirements under the provisions of the *Planning Act*.

**RESOLUTION** 0192-2020

WHEREAS on March 17, 2020, an emergency related to the COVID-19 outbreak was declared in the Province of Ontario, pursuant to Section 7.0.1 of the Emergency Management and Civil Protection Act, as set out in O. Reg 50/20; and

WHEREAS as part of other Orders made in connection with the emergency declaration, restaurants have been significantly limited in their operations, which has resulted in substantial local economic impacts; and

WHEREAS due to the emergency orders and restrictions identified by both the Province of Ontario and Region of Peel - Public Health that physical distancing be practiced in order to decrease transmission, the capacities of restaurants and patios will be limited compared to previous years; and

WHEREAS the Province is temporarily permitting licensed establishments to add or extend patios adjacent to their premises until January 1, 2021, providing they have municipal approval and the Province is waiving fees for liquor sales licensees to temporarily extend these patios; and

WHEREAS the City's Zoning By-law 0225-2007, as amended, does not permit outdoor patios accessory to any type of restaurant and regulates required parking for restaurants; and

WHEREAS local businesses have advocated for less regulation and lower fees to help small businesses as part of the recovery efforts; and

WHEREAS local restaurants have specifically requested to be allowed to establish temporary outdoor patios on public or privately owned lands with zoning and also within public rights of way, with the property owner and the City's permission; and

WHEREAS the City of Mississauga can support the local economy by providing greater flexibility for expanding outdoor patios in parking lots on private property, in public parking lots, and on public rights of way on a temporary basis, all of which is subject to the Province relaxing restrictions which have been imposed on restaurant operations through its emergency orders; and

WHEREAS the City of Mississauga is commencing the process of considering a temporary use by-law to permit outdoor patios as an accessory use to all types of restaurants in various zones;

#### NOW THEREFORE BE LET IT BE RESOLVED:

- 1. Direct staff, upon the issuance of notice for the statutory public meeting to consider a temporary use by-law, to suspend the enforcement of those zoning by-law provisions that currently prohibit or regulate outdoor patios accessory to all types of restaurants on private and public lands and that the suspension continue until the temporary use zoning by-law comes into force or until the duration stipulated for the temporary use zoning by-law expires, as may be; and
- That fees for zoning certificates, encroachment agreements, road occupancy
  permits, and any other fees required to expand or establish outdoor patios accessory
  to permitted restaurants on private and public properties in the city be waived on a
  temporary basis until December 31, 2020.
