- 5.1. Tour de Mississauga Glenn Gumulka, Executive Director, SustainMobility (15 minutes)

Glenn Gumulka, Executive Director, SustainMobility provided a verbal update regarding the 2016 Tour de Mississauga. He spoke to the 6 routes, outlined the difference between the paid and free routes, food vendors, the CCN registration system, t-shirts, jerseys, signage, rest stops and sponsorships.

6. MATTERS TO BE CONSIDERED

6.1. Introduction of Jelmer Stegink, Active Transportation Marketing and Education Specialist

Ben Gomberg (10 minutes)

Ben Gomberg, Manager, Active Transportation introduced Jelmer Stegink as the new Active Transportation Marketing and Educational Specialist. Mr. Jelmer outlined his previous work, education and cycling experience. He further spoke to being part of the Dutch National Cycling Team.

6.2. Provincial Cap and Trade Funding for Cycling Infrastructure ☐ Ben Gomberg, Manager, Active Transportation Office (10 minutes)

Ben Gomberg, Manager, Active Transportation provided background information to members of the Mississauga Cycling Advisory Committee regarding the Provincial Cap and Trade Funding for Cycling Infrastructure. He requested that the Committee write a letter of support to the Province in support of the initiative.

Councillor Fonseca expressed support of the program and noted that she would request the Mayor to write her own letter of endorsement.
