7. MATTERS TO BE CONSIDERED

7.1. Lake Aquitaine Trail Striping (Community Services 5 minutes)

Ben Gomberg, Manager, Active Transportation spoke to a field observation study of the line markings on the Lake Aquitaine multi-use trail. It was found that half the participants noticed the markings on the trail.

Members of the Mississauga Cycling Advisory Committee engaged in discussion regarding the field study and spoke to the purpose of the study, bike signs, the importance of the centre lines and future field study's to be conducted by Community Services.

RECOMMENDATION

That the Mississauga Cycling Advisory Committee supports the efforts of Community Services staff for the Field and Study Observations that staff are conducting.

- 7.2. Burnhamthorpe Trail Site Visit □ June 22, 2016 (Ben Gomberg, Manager Active Transportation and Irwin Nayer, Citizen Member 5 minutes)

Irwin Nayer, Citizen Member spoke to the Burnhamthorpe Trail site visit on June 22, 2016 and identified areas of the trail that were of concern and informed Ben Gomberg of the areas. Discussion ensued with respect to foliage along the trail and the process of reporting issues along cycling trails.

- 7.3. Cross Rides & OTC AT Committee call for crossride-crosswalk-PXO user data collection (Dorothy Kowpak, Active Transportation Coordinator 10 minutes)

Dorothy Kowpak, Active Transportation Coordinator spoke to a request from the Ontario Traffic Council Active Transportation Committee of data collection from municipalities. She enquired if committee members would be interested to participate to gather data at two locations in the City of Mississauga. Andrew Paranczuk noted that he would be interested.

- 7.4. Update to the Mid-Year Report - (Dorothy Kowpak, Active Transportation Coordinator 5 minutes)

Dorothy Kowpak, Active Transportation Coordinator spoke to the revised memorandum dated July 12, 2016 entitled: Mid-Year Update: 2016 Cycling Network Program. She noted that the data had been broken down by off-road trails, in-boulevard multi-use trails and on-road cycling facilities.

Dorothy Tomiuk, Citizen Member requested that data be provided to put on the committees website to indicate what cycling infrastructure projects are currently being constructed or proposed to be constructed.

- 7.5. Tour de Mississauga Update and Transition to SustainMobility (Donnie Morris, Citizen Member and Ben Gomberg, Manager, Active Transportation Office 15 minutes)

This item was deferred.

- 7.6. Communications and Promotions Committee (5 minutes)

Dorothy Tomiuk, Citizen Member, noted that the Communications and Promotions Subcommittee are continuing to work on the Community Rides. She enquired what the status is on the welcoming kit that staff are currently creating. Ben Gomberg, Manger, Active Transportation noted that the cycling welcome kits are finalized and that they

would be distributed to bike stores when a customer purchases a bike.

Jonathan Giggs, Citizen Member noted that in the future the cycling welcome kits should also be offered at the big box stores alongside the independent bike shops.

7.7. Community Bike Rides & Recommendation for 2016 - Donnie Morris, Citizen Member and Ben Gomberg, Manger, Active Transportation 15 minutes)

Dorothy Tomiuk, Citizen Member spoke to rescheduling the July 9, 2016 ride due to weather conditions and spoke to the upcoming orientation session for marshals.

Members of the Mississauga Cycling Advisory Committee engaged in discussion regarding the newly in placed 50 to 3 ration between riders and marshals, ensuring the groups are balanced, the importance of training marshals and that the rides are guided but not supported.

RECOMMENDATION

That staff purchase two walkie talkies to promote safety and communication on Community Rides and that the funds come from the Mississauga Cycling Advisory Committees budget.

He enquired if there is a point person to ask for any preplanned maintenance on trails that would affect the Tour. Ben Gomberg, Manager Active Transportation noted that he could contact his office.

Dorothy Tomiuk, Citizen Member and David Daglish, Citizen Member provided an update on the Britannia Farms. Members of the Mississauga Cycling Advisory Committee noted that the committee would like to see a trail tie into neighbouring infrastructure through the Britannia Farms.
