7. MATTERS TO BE CONSIDERED

7.1. 2017 Bike Map (Ben Gomberg, Manager, Active Transportation 10 minutes)

Ben Gomberg, Manager, Active Transportation spoke to the updated 2017 Bike Map and noted that the map would be printed on both sides.

Members of the Mississauga Cycling Advisory Committee expressed support of a grey coloured background and enquired about having an online bike map. Mr. Gomberg noted that he would look into it.





RECOMMENDATION:

That consideration for cycling facilities on Matheson Boulevard East be referred to the Cycling Master Plan Update.

BACKGROUND:

On-road bicycle lanes are proposed to be implemented on several streets within the Airport Corporate Centre in 2017, with funding support from the Public Transit Infrastructure Fund. The goal of these projects is to connect cyclists to Transitway stations. During discussion on these proposed improvements, the Mississauga Cycling Advisory Committee passed a recommendation directing staff to investigate the feasibility of implementing cycling facilities on Matheson Boulevard East in addition to those streets already proposed.

COMMENTS:

Matheson Boulevard East is classified as a Major Collector road with a posted speed limit of 60km/h and high operating speeds. The cross-section is 5 lanes, 2 through lanes in each direction with a centre two-way left turn lane. Through the Airport Corporate Centre, the curb-to-curb width is generally 17.5 metres, or 3.5 metres width per lane for 5 lanes.

Traffic volumes on Matheson Boulevard East in the Airport Corporate Centre are in excess of 21,000 vehicles per day, with peak hour volumes in excess of 2800 vehicles per hour. Given these traffic volumes, a lane conversion using the existing road width is not feasible. City guidelines for lane conversion recommend no greater than 700 vehicles per lane in the peak hour, and no greater than 20,000 vehicles per day. Matheson Boulevard East operates in these conditions today as currently configured, and would not operate if a road diet were implemented to create space for on-road bicycle lanes with less road space allocated to vehicles.

In the Airport Corporate Centre, bicycle lanes will be implemented east/west along Explorer Drive and north/south along Spectrum Way and Orbitor Drive, as shown in Appendix 2. As well, multi-use trails are being implemented along Eglinton Avenue East along with the Transitway. Given the traffic characteristics on Matheson Boulevard East, a separated or boulevard cycling route would be recommended. The cost to implement such a separated facility while parallel routes are already in place may not be an effective use of resources. The current Cycling Master Plan does not identify Matheson Boulevard East as a candidate for a cycling facility, except for a 1.7 km section between Little Etobicoke Creek and Kennedy Road, under Highway 403 which is identified as a Proposed Secondary Bike Route.

NEXT STEPS:

The Cycling Master Plan Update will include a review of the recommended cycling network from the 2010 plan. Recommendations for Matheson Boulevard East can be reviewed in the context of the network-wide review, potential connections to the facilities being implemented in the Airport Corporate Centre in 2017, and the implementation of the Hurontario LRT which includes a stop at Matheson Boulevard and Hurontario Street.




