5.1. Dundas Connects Deputation from Andrew Miller, Strategic Leader (10 minutes)

Ben Gomberg, Manager, Active Transportation spoke to accomplishments achieved in February. He outlined the following projects: Dundas Connects; Dundas Street bridge; parking on Traders Blvd; and the Cycling Master Plan.

Brandon Quigley, Planner, Sustainable Transportation spoke to the upcoming Bike to School Week taking place from May 29, 2017 – June 2, 2017. He encouraged additional Peel Regional schools to sign up and noted that schools are always looking for volunteers to ensure routes are safe for students to ride.
