7.3. Action Item List Reintroduction (Stephanie Smith, Legislative Coordinator 5 minutes)

Stephanie Smith, Legislative Coordinator spoke to the reintroduction of an action item list and that if any committee members had any future agenda items that they would like added to the agenda to let her know.

## 7.4. 2017 Tour de Mississauga Update

Jelmer Stegink, Marketing and Education Specialist spoke to the memorandum entitled 2017 Tour de Mississauga Update and informed the committee of Councils support of this year's Tour de Mississauga and that the BRT might not be an option for a route. He further spoke to the roles of SustainMobility and the roles of the City of Mississauga.

Mississauga Cycling Advisory Committee (MCAC) engaged in discussion regarding: the age requirement to be able to ride for free; reusing some resources from the 2016 Tour de Mississauga; the 5km and 10km route design; and that a task sheet needs to be developed for members of the committee to sign up for various tasks.

The Transportation and Works Department has prepared a list of locations where bicycle facilities are proposed for construction in 2017.

These locations have been selected based on the criteria contained within the 2010 Cycling Master Plan and in coordination with other City of Mississauga and/or Region of Peel capital projects. The focus in 2017 is on connections to public transit stations, including GO and BRT. Public Transit Infrastructure Fund (PTIF) grants require this focus. As shown below, the 2017 Transportation and Works program represents one component of work underway by multiple departments and levels of government and represents an ambitious plan to grow cycling infrastructure in the City of Mississauga.

The PTIF funding was officially confirmed on March 31, 2017, at which point finalized designs, public notifications (where required) and utility relocations (where required) were able to begin.

Please note that the nature and schedule of the proposed projects listed herein are subject to change in accordance with budget, engineering and construction constraints, public consultation and Council approval.

#### Mandate

The Road Safety Committee provides a community perspective on road safety issues, promotes public awareness and education for road safety initiatives and programs, with an aim to enhance community participation and cooperation. Road Safety Mississauga will consult with and promote partnerships with other committees and agencies, while supporting ongoing City programs and projects in an effort to raise the profile of road safety in Mississauga.

Appointed members are expected to participate in promotional events on a regular basis to raise awareness related to road safety to residents and business.

#### **Objectives/Goals**

The objective of the Road Safety Committee is to promote road safety for all methods of transportation, including pedestrian, cyclist and vehicular traffic.

Through the creation of various initiatives and programs, the Committee will regularly disseminate information to the public on various road safety issues.

#### **Work Plan**

The Road Safety Committee shall prepare annual Work Plans which will be sent to General Committee, then to Council at the beginning of the New Year, as well as a progress update at the end of the year. Committee members shall work collaboratively with City staff to devise these Work Plans to ensure that the workload is manageable and appropriately shared between the two parties.

Work plans will need to be carefully crafted in order to meet the Committee's mandate and objectives, as well as the City's Strategic Plan, Master Plans, and budgetary capacity.

The work plan shall speak directly to the specific goals the committee aims to accomplish. The work plan for each Advisory Committee attempts to use the City's Strategic Plan Pillars, action items, master plans, or legislation as sub-headings to organize the committee's focus and nature of work. The Committee shall present its accomplishments as they relate to the work plan, to Council annually.

#### **Definitions**

Definitions are provided for the purpose of clarity and only where necessary.

That definitions provided are referenced to the appropriate source/legislation.

## **Procedures and Frequency of Meetings**

All Committees are subject to Council Procedure By-law, which outlines the procedures for Council and Committee meetings. http://www7.mississauga.ca/documents/bylaws/procedural\_by-law\_2013.pdf

The Road Safety Committee will meet approximately 4 times per year or as determined by the Committee at the call of the Chair. In addition to attending Committee meetings, members of the Road Safety Mississauga Committee will be expected to attend community events to promote road safety messaging and community participation.

All members are subject to the Code of Conduct and Complaint Protocol for Local Boards.

The Road Safety Mississauga Committee shall be comprised of:

- 2 Councillors;
- 8 Citizen Members;
- A representative from each of the: Traffic Safety Council and the Mississauga Cycling Committee.

In addition to the Council appointed members of the Committee, the following are non-voting members who serve as a resource to the Committee:

- Peel Regional Police;
- Ontario Provincial Police;
- Ministry of Transportation Ontario Road Safety Marketing Branch;
- Peel Region Traffic Safety;
- Region of Peel Health Unit;
- City of Mississauga Traffic Staff;
- Region of Peel Traffic Staff;
- Communications representative from Transportation and Works.

In addition, other agencies, organizations and staff may be invited to attend as required.

## **Role of Chair**

The Chair of the Committee will be appointed at the first meeting of the Committee.

The role of the Chair is to:

- 1. Preside at the meetings of Road Safety Committee using City of Mississauga's Procedure By-law, and keep discussion on topic.
- 2. Provide leadership to the Road Safety Committee to encourage that its activities remain focused on its mandate as an Advisory Committee of Council.
- 3. Review agenda items with the Committee Coordinator and Traffic Operations staff.
- 4. Recognize each Member's contribution to the Committee's work.
- 5. Serve as an *ex-officio* member of subcommittees and attend subcommittee meetings when necessary.
- 6. Liaise with the Supervisor of Road Safety, Transportation and Works, on a regular basis.

## **Role of Committee Members**

The role of Committee Members is to:

- 1. Ensure that the mandate of the Road Safety Committee is being fulfilled.
- 2. Actively participate in the promotion of road safety at the city or other events as determined by the Committee.
- 3. Notify the Committee Coordinator if they are unable to attend meetings to ensure that quorum will be available for all meetings.

## Quorum

- 1. Quorum of the Road Safety Committee shall be reached with the presence of a majority of the appointed and elected members, at a time no later than thirty (30) minutes past the time for which the beginning of the meeting was scheduled and so noted on the agenda or notice of the meeting.
- 2. The issuance of an Agenda for a meeting of this Committee will be considered as notice of that meeting.
- 3. The presence of one (1) of the appointed Council members shall be required to establish quorum.

## **Subcommittees**

That, as per the Procedure By-law 139-2013, a Committee of Council may establish a subcommittee which shall consist of members of the parent

Committee, as may be determined by such parent Committee and any other member approved by Council.

- Sub-committees will be formed to deal with specific issues, and will make recommendations to the parent Committee. Once the specific issue is dealt with the subcommittee shall cease.
- All appointed members of the subcommittee have the right to vote.
- The Chair of the subcommittee will be appointed at the first meeting of the subcommittee.

## Introduction

The following summary provides an update on the activities undertaken for the Does Cycling Move You project (Cycling Master Plan Update) and upcoming milestones. The project is currently in Phase 2: Identifying Needs and Opportunities. The following consultation activities have been undertaken to inform this phase.

## Does Cycling Move You Public Open House

An interactive public open house was held on June 21 from 3:30pm to 7:30pm. 22 interactive display boards were provided that used dot stickers and comment notes to record input on various aspects of the cycling master plan update. Feedback on the recommended 2010 Cycling Network was collected on a large map and participants recorded their "big ideas" on how to make Mississauga more bicycle friendly. The online survey was also available in a Survey Zone for participants to complete. There were 31 attendees over the course of the meeting. A summary of the feedback provided at the meeting and copies of the display boards have been posted on the Does Cycling Move You website: DoesCyclingMoveYou.ca. Overall, comments focused on the desire to see the proposed cycling network completed to provide continuous cycling routes across the city. Several comments were given indicating a preference among participants for separated bicycle infrastructure that provides cyclists with a dedicated space that is not mixed with cars or pedestrians. There were a number of comments asking for improved crossings at barriers such as highways, railways, and watercourses.

## **Does Cycling Move You website**

Feedback continues to be collected through the Does Cycling Move You website. Since the site was launched, 2,100 visits have been recorded, with 1,574 people visiting at least one page on the site. Approximately 40% of visitors to the site are visiting multiple pages, downloading documents and/or engaging with the tools.

## **Cycling Survey**

There has been a high level of participation on the Cycling Survey. Since fall/winter 2016, there have been 2,047 responses to the survey. Of these, 427 responses have been collected since the launch of the Does Cycling Move You project.
