4. MINUTES OF PREVIOUS MEETING

4.1. Mississauga Cycling Advisory Committee Minutes - February 13, 2018

5. DEPUTATIONS

5.1. <u>Darnel Harris, Resident with respect to the Light Rail Transitway</u>

No discussion took place.

5.2. <u>Wai-Lyn Wong, Project Engineer, Pratt & Whitney Canada (P&WC) with respect to the Cycling Master Plan (10minutes)</u>

Ms. Wong spoke to the Mississauga Cycling Master Plan update and noted that P&WC would appreciate if the City of Mississauga considers the following 5 priority routes for cycling infrastructure: Etobicoke Creek; Courtneypark Drive; Eglinton Road; Derry Road and Tomken Road. She further requested that the routes be commuter friendly and safe.

Irwin Nayer, Citizen Member enquired about the type of infrastructure that P&WC would prefer. Ms. Wong noted they would prefer dedicated bike lanes.

Jonathan Giggs, Citizen Member enquired if they would sponsor the Community Rides and discussion ensued with respect to on-road and off-road cycling infrastructure.

RECOMMENDATION

Aly, Resident enquired why the City of Mississauga continues to build multi-use trails as more commuter infrastructure is needed. Matthew Sweet, Manager, Active Transportation spoke to the detailed design of projects and the updated Cycling Master Plan.

7. MATTERS CONSIDERED

7.1. <u>Tour de Mississauga – Long Term Strategy (Jelmer Stegnik, Active Transportation Marketing and Education Specialist 10 minutes)</u>

Mr. Stegnik spoke to the 2018 Tour de Mississauga and the involvement of SustainMobility. He outlined the promotion of routes, future opportunities and that future Tours would move to a third party model with financial support.

Jonathan Giggs, Citizen Member enquired if the Cycling Master Plan could be an opportunity to ask for additional resources. Mr. Sweet spoke to the benefits to moving the Tour de Mississauga to a third party model.

7.2. <u>Cycling Master Plan Update (Matthew Sweet, Manager, Active Transportation 10 minutes)</u>

Mr. Sweet noted that staff are in the final report writing phase for the Cycling Master Plan Update and that a final draft should be completed by early April. He outlined future target dates for the Cycling Master Plan.

Jonathan Giggs, Citizen Member, spoke to the map that is currently online.

7.3. Ontario Bike Summit (Donnie Morris, Citizen Member 5 minutes)

Members of the Committee discussed the Ontario Bike Summit taking place on April 17 and 18, 2018.

RECOMMENDATION

7.4. <u>Community Rides Update (Jonathan Giggs, Citizen Member 5minutes)</u>

Jonathan Giggs, Citizen Member spoke to a 2018 draft Community Ride schedule.

Jelmer Stegnik, Active Transportation Marketing and Education Specialist spoke to a training ride session for volunteers, number of rides, a bike challenge, that rides would not be rescheduled due to rain, the Community Ride registration system, recruiting new volunteers and working with CanBike instructors.

7.5. <u>Mississauga Cycling Advisory Committee 2018 Work Plan (Donnie Morris, Citizen Member 5 minutes)</u>

Stephanie Smith, Legislative Coordinator noted that the Committees 2018 Work Plan had been approved by General Committee and would go to Council to be adopted.

7.6. <u>Communications and Promotions Subcommittee Update (Dorothy Tomiuk, Citizen Member 5 minutes)</u>

Members of the Committee discussed the written Communications and Promotions Subcommittee Update from Dorothy Tomiuk, Citizen Member. Discussion ensued with respect to the Etobicoke Creek Trail signage and paving of the trail. Matthew Sweet, Manager, Active Transportation noted that staff would report back on the Committees concerns regarding the Etobicoke Creek Trail.

7.7. Road Safety Mississauga Update (Leonard Verwey, Citizen Member 5minutes)

Mr. Verwey provided an update on the Road Safety Mississauga Committee (RSM) and spoke to a staff presentation regarding road safety tools and devices, the RSM work plan and a roundabout safety campaign.

Mr. Sweet noted a Cycling Master Plan presentation would be brought to a future RSM meeting.

7.8. <u>Network and Technical Subcommittee Update (Donnie Morris, Citizen Member 5</u> minutes)

No update provided.


8. <u>OTHER BUSINESS</u>

Hello Leonard,

Thank you for your interest in the *Queen Elizabeth Way (QEW) Improvement Project from east of Cawthra Road to The East Mall* and for attending the Public Information Centre on December 18, 2017.

Item 1:

Your comments regarding speed limits and improvements for the QEW southbound on-ramp at Dixie Road.

MTO has been in consultation with the Region of Peel and City of Mississauga regarding their regulations for speed limits on municipal roads such as on Dixie Road. Speed limits on municipal roads will only be adjusted as determined by the municipalities.

A Multi-Use Trail (MUT) is proposed along the North Service Road to accommodate the City's request to include a new Multi-Use Trail(between Westfield Drive and Dixie Road) along the North Service Road to complete their east – west cycling facility and provide a connection to the Ogden Avenue Pedestrian Bridge and the proposed Dixie Road Multi-Use Trail. A Multi-Use Trail is not proposed along the South Service Road as there is insufficient room for an MUT.

Regarding the impacts of the intersections and ramps to the MUT on Dixie Road; all crossings will be designed to the latest MTO design standards for bike lanes/MUTs at intersections and ramps. MTO will continue to consult with the City of Mississauga and Region of Peel throughout the Detail Design phase

of Contract 2 (which extends along the QEW from East of Cawthra Road to West of Etobicoke Creek Bridge).

Item 2:

We note your comment about minimizing the closure of Ogden Pedestrian Bridge during construction and providing an active transportation link to the Mississauga cycling network.

Full nighttime closure of the QEW eastbound and westbound lanes will be necessary for the removal and installation of the Ogden Avenue Pedestrian Bridge. To minimize the impact to the Elementary Schools in the vicinity, the Project Team will try to coincide the closing of the Ogden Pedestrian Bridge with the end of the school year and the summer break. The Project Team will work to determine the closure period and explore provisions so impacts to pedestrians are minimized. Also as noted above, the new Multi-Use Trail (between Westfield Drive and Dixie Road) along the North Service Road will be provided to complete the City of Mississauga east – west cycling facility and provide a connection to the Ogden Avenue Pedestrian Bridge and the proposed Dixie Road Multi-Use Trail.

We note your comment regarding the closure of the Etobicoke Creek Trail, as part of Contract 1 (which extends along the QEW from West of Etobicoke Creek to The East Mall). The trail currently terminates on either side of the QEW / Etobicoke Creek Bridge. The trail is owned by the City of Toronto. On behalf of the City of Toronto, the Toronto and Region Conservation Authority (TRCA) has plans to construct a connecting trail below the QEW.

In the area below the QEW, construction of the trail is not anticipated to occur until MTO's Contract 1 works are completed. The area under the Etobicoke Creek Bridge within the MTO right-of-way will be closed during construction of Contract 1 for safety reasons (anticipated to be four (4) years) and signage will be provided to notify the public. The City of Toronto and TRCA have been consulted and are aware of these closure requirements during Contract 1 construction.

Item 3:

We note your recommendation for dust mitigation and landscaping on the project.

Contract provisions will require the Contractor to minimize impacts to adjacent properties during construction (e.g., dust control measures).

As part of Contract 1, a Landscape Plan has been developed for the Etobicoke Creek valley within MTO's right-of-way and will be implemented during construction. On Contract 2 a Landscape Plan will be developed for the Dixie Road Interchange within the MTO and Municipal right-of-way.

Further detail design work on Contract 2, including landscape design, will be undertaken in the future. Once detail design is complete a Design and Construction Report (DCR) covering works on Contract 2 only will be prepared and made available for a 30-day public review period.

Item 4:

Your comment is noted regarding concerns about Dixie Road south of the project going from 2 lanes to one lane in each direction and your concern for cyclists.

A Multi-Use Trail will be provided on Dixie Road from south of Kendall Road southerly through the study limits to the newly relocated Dixie Outlet Mall south entrance. Beyond the limits of this project you are encouraged to contact the City of Mississauga and Region of Peel regarding your request to consider continuing the Multi-Use Trail from the south limit of the project to Lakeshore. Item 5:

Your comment regarding making improvements to existing provincial overpass structures with proper cycling height barrier walls & railings is noted. As part of the Ministry of Transportation bridge rehabilitation program railing heights will be evaluated on a structure by structure basis.

Other:

In terms of timelines of the project, currently, construction of Contract 1 is anticipated to take place over four construction seasons. Construction works are anticipated to commence in Summer 2018 and extend until Winter 2021, pending obtaining all required approvals and agreements. Timelines are subject to change.

In the coming weeks a DCR covering works on Contract 1 only will be prepared and made available for a 30-day public review period which will document:

- The design details of the proposed improvements
- A summary of potential environmental effects and mitigation measures
- A summary of consultation undertaken throughout the project
- Landscape design

Notification, advising of the times and locations of the availability of the DCR for review will be published in local newspapers and mailed to those on the Project Contact List.
