Mr. Sweet spoke to the draft Cycling Master Plan and requested that the Committee write a letter of endorsement.

Donnie Morris, Citizen Member and Jonathan Giggs, Citizen Member expressed concerns with the timeline that was previously presented to the Committee. Mr. Morris noted that before the Committee writes a letter of endorsement they would like to review the presentation prior to it being presented to the Leadership Team.

Subject: Quarterly Cycling Capital Program Update

The Transportation and Works Department has prepared a list of locations where bicycle facilities are in design or under construction in 2018.

These locations have been selected based on the criteria contained within the 2010 Cycling Master Plan and in coordination with other City of Mississauga and/or Region of Peel capital projects. The focus in 2018 is on connections to public transit stations, including GO and BRT. Public Transit Infrastructure Fund (PTIF) grants require this focus. As shown in the following tables, the 2018 Transportation and Works program represents one component of work underway by multiple departments and levels of government, and represents an ambitious plan to grow cycling infrastructure in the City of Mississauga.

Please note that the nature and schedule of the proposed projects listed here are subject to change in accordance with budget, engineering and construction constraints, public consultation, and Council approval.
