7. PUBLIC QUESTION PERIOD - 15 Minute Limit

Glenn Voakes, Resident spoke to item 8.1 and enquired about the progress that has been completed and questioned how many kilometers were delivered in 2018, 2019 and what is planned for 2020. Mr. Voakes further spoke to the number projects being deferred and the City of Mississauga's performance levels. Fred Sandoval, Active Transportation Coordinator responded to questions and spoke to the 2018 completed kilometers. Councillor Fonseca spoke to quarterly input into capital projects from Members of the Committee and the reasons for deferrals of projects.

Peter Sanster, Resident and enquired about support from the Peel Regional Police (PRP) regarding cycling. Councillor Fonseca spoke to the PRP and Corporate Security on Community Rides and future opportunity to involve PRP and Corporate Security. Matthew Sweet, Manager, Active Transportation spoke to strategically involving the PRP on the Committee.

Nick Morrison, Resident, spoke to item 8.1 and enquired when the data from the bike counters would be made available on the open data portal. Fred Sandoval, Active Transportation Coordinator and Matthew Sweet, Manager, Active Transportation spoke to the data collected from the bike counters.

Jonathan Giggs, Resident spoke to 9.1 and enquired about the Share the Road discounted community member ticket. Matthew Sweet, Manager, Active Transportation spoke to future discussion on the discounted community member ticket.

8. MATTERS CONSIDERED

8.1 Quarterly Cycling Program Update (30 minutes)

Fred Sandoval, Active Transportation Coordinator spoke to the Quarterly Cycling Program Update.

Members of the Committee spoke to the matter and made the following comments: the reason for the deferral of the Winston Churchill Boulevard and Highway 403 project; the consultant for the Collegeway Project; the status for the Erin Mills Parkway bike lanes to connect to the BRT; communication for temporary detour signage to connect Erin Mills Parkway to the BRT; the status for bike lanes to connect to the new Community Center on Ninth Line; the need for additional crossings along the Ninth Creeks Trail; the need to work together with various Committees of Councils on a communication plan on the implementation of edge lines; the need for consistency on design between the Region of Peel and the City of Mississauga; the need for paint and signage at crossroad locations to be very clearly laid out; and the need for standardization of curb transition.

Mr. Sandoval responded to questions.
