7. **MATTERS CONSIDERED**

7.1. Clerk's Report dated July 9, 2019 from the Director of Legislative Services and City Clerk: **Legislated Contribution Report Overview** regarding contributions from the following contributors: Diane Ferri/Diane Ferri-Gisone, City of Toronto (Appendix 1) and Tim Warner, City of Toronto (Appendix 2)

Ron Colucci, Chair, gave an overview of the purpose of the meeting and spoke briefly to the contribution contravention reports submitted by the City Clerk and the powers of the committee.

Appendix 1: Diane Ferri/Diane Ferri-Gisone, City of Toronto

Laura Wilson, Elections Officer, provided an overview of the report and spoke to Diane Ferri/Diane Ferri-Gisone possibly exceeding the contribution limit of \$5000 as outlined under section 88.9(4) of the *Municipal Elections Act*. Ms. Wilson noted that the two similar names with the same address were taken from Brad Butt's (Candidate, Ward 1) financial statement which outlined contributions totaling \$5,250.

Members of the committee engaged in a discussion regarding the letters and supporting documents received from Brad Butt, Diana Ferri-Gisone and Dino Ferri that spoke to Diane Ferri and Diana Ferri-Gisone being two different individuals residing at two different addresses. The committee noted that the two cheques received by Brad Butt from Diane Ferri and Diana Ferri-Gisone were from two different banks, the signatures on the two cheques were different and that Diana Ferri-Gisone's name was misspelled on the financial statement.

Based on the information provided, the committee moved not to proceed with legal action against Diane Ferri and Diana Ferri-Gisone as there was no contravention under Section 88.9(4) of *Municipal Elections Act*. The committee determined that Diane Ferri

and Diana Ferri-Gisone were in fact two different individuals residing at different addresses.

DECISION

Appendix 2: Tim Warner, City of Toronto

Laura Wilson, Elections Officer, provided an overview of the report and spoke to Tim Warner exceeding the contribution limit of \$1200 to one candidate as outlined under section 88.9(1) of the *Municipal Elections Act*. Ms. Wilson noted that according to Brad Butt's (Candidate, Ward 1) financial statement, Tim Warner made two separate contributions which totaled \$1700.

Members of the committee engaged in a discussion regarding the letter and supporting documentation received from Brad Butt which outlined that one of the contributions in the amount of \$700 was from Ignat Knaff and not Tim Warner. The letter from Mr. Butt noted that there was a clerical error on his financial statement. Members asked

questions in regards to the financial statement submitted by Mr. Butt which were answered by staff. The committee noted that the cheque given to Mr. Butt by Ignat Kaneff correlated to the documents that Mr. Butt submitted.

Based on the information provided, the committee moved not to proceed with legal action against Tim Warner as there was no contravention under Section 88.9(1) of *Municipal Elections Act*. The committee determined that due to a possible clerical error by Mr. Butt, that Tim Warner's contribution was \$1000.

WHEREAS, pursuant to section 88.34(1) of the Municipal Elections Act, 1996, as amended, (the "Act"), the Clerk shall review the contributions reported on the financial statements submitted by a candidate under Section 88.25 to determine whether any contributor appears to have exceeded any of the contribution limits under Section 88.9;

Brief written reasons provided by the Committee:

The Election Campaign Finance Committee determined that there was no contravention to the Municipal Elections Act, pursuant to Section 88.9.

That based on the evidence provided by candidate Brad Butt, including a letter and copies of the corresponding cheques, the Election Campaign Finance Committee will not commence with legal action against the contributor for the following reasons:

- Candidate submission that this was a clerical error with supporting documentation;
- The two contribution cheques were submitted by different individuals, from different banks, different signatures and different addresses.
