- 5.1. Obie Agusiegbe, EnvironFocus spoke with respect to supporting environmental initiatives from the private sector in Mississauga.  
Ms. Agusiegbe advised that EnvironFocus is an environmental consulting firm that is focused on building sustainable partnerships with organizations and the community which includes environmental education, access to clean technology, and designing and implementing training programs and projects.

Councillor Mahoney inquired as to whether EnvironFocus is a business, to which Ms. Agusiegbe confirmed that it is.

Lea Ann Mallett, Citizen Member commented that there are non-profit organizations doing the same work, to which Brenda Osborne, Director, Environment further noted that the Environment Division hosts Earth Markets, connects with non-profit groups, and employs environmental staff to implement programs, events, and policies.

Councillor Mahoney suggested that the EnvironFocus organization be referred to staff to review their proposal and provide comments at an upcoming Environmental Action Committee meeting.

- 5.2. ## 6. MATTERS CONSIDERED

### 6.1. Environmental Action Committee Work Plan Update

Brenda Osborne, Director, Environment provided a brief verbal update with respect to the Environmental Action Committee Work Plan noting the success of the Appreciation Event, the upcoming opportunity for EAC Members to be involved with Green Fest, and that two by-laws would be reviewed that the Committee can provide comments on.

Dave Beaton, Credit Valley Conservation inquired about the by-law regarding boulevard gardens, to which he was advised that Council had approved boulevard gardens and that staff are currently writing the by-law. Mr. Beaton asked if staff could bring that by-law to EAC for review, to which Ms. Osborne advised that she would ask staff to do so.

### 6.2. Environmental Action Committee Work Plan Session

Councillor Mahoney briefly reviewed the role of the Environmental Action Committee noting that EAC is a committee of citizens who are committed, engaged, and participating in green initiatives. Councillor Mahoney asked for input on next steps in finalizing the EAC Work Plan.

Joanne Deidun-Roork, The Little Green Schoolhouse noted that the current plan focuses on education and that the Committee's environmental actions, such as volunteering at the Earth Market and Green Fest, demonstrated EAC's success in providing education. Ms. Deidun-Roork further noted that she has been doing mini events at the school to provide information to the community and inquired as to what the protocol is for EAC in supporting the Earth Markets.

Councillor Mahoney noted that volunteering at the Earth Market is supportive and helps the community, to which Ms. Osborne added that Members have their own existing networks to promote City events and encouraged all Members to do so.

Ms. Deidun-Roork noted that EAC should engage and support the Living Green Master Plan (LGMP), to which Councillor Mahoney noted that staff could review the LGMP to see if there are areas that EAC could provide additional support.

Ms. Osborne advised that the LGMP will be up for review in 2017 and that the Plan would come to EAC for review/input.

Mr. Beaton commented that the update to the LGMP was a collaborative effort, as there are a number of initiatives that other organizations have a major role in implementing. Mr. Beaton further noted that Credit Valley Conservation is moving forward in implementing items on the LGMP and checking in with other organizations.

Chelsea Dalton, Citizen Member inquired whether Members could suggest that certain current policies should be reviewed, to which Ms. Osborne noted that two by-laws are up for review and would be coming to EAC.

Ms. Osborne and Ms. Morden noted that they would revisit organizing the current Work Plan.

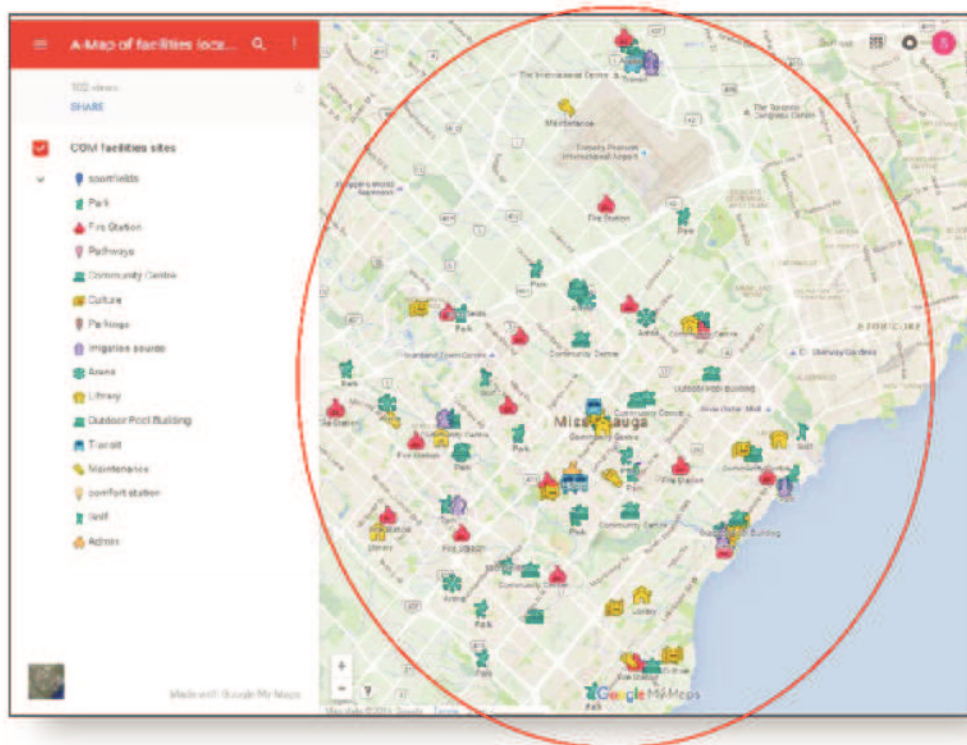

## Recommendation

1. That the Corporate Report titled "City Wide Energy Audit Results" dated June 24, 2016 be received for information.
2. That the City will endorse the study to satisfy the financial grant agreement between the City and Federation of Canadian Municipalities.

## Report Highlights

- In line with the City's 5 Year Energy Conservation Plan goals of achieving 1% reduction in energy consumption and greenhouse gas emissions each year, staff retained engineering consulting firms to identify energy efficiency measures in City's top 100 energy-consuming facilities.
- A comprehensive list of energy reduction measures ranging from payback of 2 to 30 years has been identified in the study, which will be utilized by staff to develop business cases for implementation through future annual budget requests.
- Funding for priority energy reduction measures (lighting and building automation system upgrades) from the study has already been approved through the 2016 capital budget plan. They are currently being implemented, with more planned for future implementation.
- Federation of Canadian Municipalities requires the study be endorsed by the Municipal Council as a condition of providing the grant. The expected grants are estimated to cover up to 80% of the total study costs of \$400,200.

## Background

The City Wide Energy Audit was initiated based on the goals laid out in the City's 5 Year Energy Conservation Plan. The study originating from the audit qualified for financing in the form of pre-approved grants of up to 80% of the total study costs from external agencies. The external

agencies include the Independent Electricity System Operator (formerly Ontario Power Authority), Enersource, and Federation of Canadian Municipalities (FCM). As a condition of providing the grants, FCM requires that the study be endorsed by Council and that future annual capital budget plans utilize the study to promote energy conservation within the City.

## Comments

Upon receiving approval from Council, staff retained two engineering consulting firms to conduct the study across 100 City properties. WSP Global Inc. and MCW Consultants Ltd. were retained through a publicly advertised Request for Proposal (RFP) process. The study was completed over a 17 month period, with final submission received in March 2016. The study has compiled a comprehensive list of energy reduction measures in the areas of heating, ventilation, air-conditioning, refrigeration, lighting, lighting controls, building envelope, water conservation, waste heat recovery, and renewable energy measures. The total cost of all identified measures has been estimated to be \$15,907,900. The estimated annual energy and water cost savings were identified to be \$2,133,300. Implementation of all the measures would result in an estimated annual reduction of 3,300 tonnes of greenhouse gas emissions. Paybacks for various measures range from approximately 2 to 30 years. Staff have already reviewed all the identified energy reduction measures and are currently in the process of developing business cases for feasible measures to be submitted for funding approval each year as part of the Facilities & Property Management's annual capital budget requests.

To demonstrate the commitment towards the 5 Year Energy Conservation Plan, the City has already approved funding for implementation of priority energy reduction measures (lighting and building automation system upgrades). A budget of \$718,000 was approved as part of the 2016 capital budget plan in order to implement these projects. The projects are estimated to provide annual savings of \$97,400 as a result of reduced energy consumption. In addition, staff have developed business cases for additional energy reduction measures which would be subject to annual capital budget approval process.

In addition to energy retrofits, the study has also recognized the ongoing success of energy awareness initiatives within the organization, stating that:

- Facility operators were aware of energy efficiency;
- Energy champions have been identified in facilities;
- Mechanical equipment and temperature set-points had in many cases been chosen with energy conservation in mind;
- Many building occupants were turning off lights in naturally day-lit areas and in areas after leaving them; and
- Occupants were aware of energy conservation as a shared value at the City.

## Strategic Plan

The study endorsement and future planning of the identified energy reduction measures would be an important step in achieving our environmental goals as outlines in the Green Pillar of the Strategic Plan. The implementation of all the identified measures has the potential to reduce 3,300 tonnes of greenhouse gas emissions each year.

## Financial Impact

Funding for implementing the feasible energy reduction measures will be requested through Facilities & Property Management's annual capital budget request process. The business case for measures to be submitted each year would be prepared keeping in mind various factors, including the extent of design and engineering work required, grouping together similar types of work, disruption of programs within facilities, synchronization with other redevelopment projects as well as savings potential.

## Conclusion

While the study should be endorsed in order to satisfy FCM's condition of providing the grant, it is recommended that it be further utilized by staff to continually promote a culture of conservation within the City. Such steps would demonstrate the City's commitment to our 5 Year Energy Conservation Plan and our green strategic goals by encouraging environmentally responsible approaches.
