#### 1. CALL TO ORDER – 9:30 AM

Chair Mahoney called the meeting to order at 9:30 AM and requested for all those present at the meeting to introduce themselves to the group.

#### 5. **DEPUTATIONS**

5.1. The Riverwood Conservancy with respect to programming and partnerships.

Douglas Markoff, Executive Director, The Riverwood Conservancy (TRC) and Kevin Sherwin, Chair, Board of Directors welcomed the Committee and spoke briefly to the background of The Riverwood Conservancy, noting that it is an independent charity that provides environmental education, stewardship, gardening and horticulture. Mr. Markoff spoke about the upcoming fundraiser and introduced Dave Taylor, Education Program Director and Kirushanth Gnanachandran, Stewardship Coordinator.

Mr. Taylor spoke to the educational programs at TRC that serve elementary and secondary school students and noted the wildlife that resides on the property. Mr. Taylor further commented on a survey of residents who live surrounding TRC that received a 40% return rate with very supportive feedback about TRC.

Mr. Gnanachandran spoke to the coordination of volunteers, noting that over 1400 trees and shrubs had been planted on the property.

Alex Dumesle, Community Group Member thanked TRC staff and inquired as to their biggest goals in the future, to which Mr. Markoff commented on education, property enhancement and stewardship, and to the Enabling Garden that allows people of all abilities to enjoy garden activities. Mr. Markoff further noted that they wish to involve all

5.3. <u>Andrea J. McLeod, Environmental Specialist regarding an update on the 2016 Earth</u> <u>Markets.</u>

> Andrea J. McLeod, Environmental Specialist provided a verbal update with respect to the remaining Earth Markets in 2016, noting that the next would be on September 17, 2016 in partnership with the Burnhamthorpe SNAP, and would take place at Burnhamthorpe Community Centre, and the final on November 5, 2016 at the Meadowvale Theatre. Ms. McLeod further noted that the first Earth Market on May 28, 2016 was very successful with 500 attendees, which was an increase from 2015.

Joanne Deidun-Roork, Community Group Member commented on the success of the event and suggested that The Riverwood Conservancy be host to a 2017 Earth Market and that the Environmental Action Committee could be at the event to highlight "EAC Environmental Actions". Ms. Deidun-Roork spoke to the Green Living Show in Toronto, noting that Mississauga could do something similar.

Councillor Carlson suggested that a Green Show could be part of the Streetsville Bread & Honey Festival next year, noting that the event could take place indoors.

Alex Dumesle, Community Group Member inquired as to whether any special consideration had been given to the September 17, 2016 Earth Market in light of the Hickory Drive incident, to which Ms. McLeod advised she is in contact with Ward 3 Councillor, Chris Fonseca.

Eashan Karnik, UTM Student Member spoke to UTM's connection with Apple Tree Markets and noted that he would provide information to Ms. McLeod.

#### 6. MATTERS CONSIDERED

#### 6.1. <u>City Wide Energy Audit Results</u>

Daniela Paraschiv, Manager, Energy Management provided background information on the report with respect to costs and pre-approved grants from IESO and FCM to cover 90% of the cost of the study. Ms. Paraschiv further advised that FCM requires City Council to endorse the study in order to release the incentives and provided highlights on the City Wide Energy Audit, noting that the audit considered 100 facilities in total. Ms. Paraschiv spoke to the goals of the Energy Audit, the energy reduction opportunities, the paybacks for various measures, and spoke to the implementation of the study.

Charles Cooper, Citizen Member noted the substantial improvements from the previous Energy Audits and requested clarification on FCM.

Brad Bass, Citizen Member inquired as to whether they had considered planting trees to reduce energy, to which Ms. Paraschiv noted that perhaps they would consider it in the future.

Shalini Srivastava Modi, Energy Management Coordinator noted that the Parks and Forestry Division was relied upon to plant trees, to which Councillor Mahoney agreed and made note of the 1 Million Trees program at the City.

Alex Dumesle, Community Group Member spoke to challenging the consultants to rethink the structure of such projects and advised that they could contact Partners in Project Green if they required input.

Eashan Karnik, UTM Student Member inquired about grant limitations, to which Ms. Srivastava Modi noted that there are several grants and the need to qualify for each one individually.

The Committee expressed support of the endorsement of the City Wide Energy Audit Results.

Melanie Kramer, Community Group Member inquired about the boulevard garden bylaw, to which Councillor Mahoney advised that the by-law had been approved by Council and that the Committee had been updated previously.

The City of Mississauga has initiated a Transportation Master Plan (TMP) and Implementation Strategy for Lakeshore Road between Southdown Road and the east City limit and Royal Windsor Drive between Southdown Road and the west City limit. The study will also evaluate rapid transit alternatives east of Hurontario Street as well as extending rapid transit into the Port Credit area.


# NOTICE OF STUDY COMMENCEMENT

### **The Process**

This Study will follow the master planning process described in the Municipal Engineers Association Municipal Class Environmental Assessment (October 2000, as amended in 2007, 2011, and 2015). The project will involve multi-modal transportation planning, urban design, and land use planning. The Master Plan process will satisfy Phases I (Identify Problem and Opportunity) and II (Identify and Evaluate Alternative Solutions to the Problem or Opportunity) of the Municipal Class EA process.

### Consultation

A key component of the study will be consultation with stakeholders, residents, regulatory agencies and the general public. Anyone with an interest in this study has the opportunity to get involved and provide input. Three rounds of Public Information Centres (PIC) will be held during the study to present findings and receive public input. A notice providing the time and location of the PIC will be published in local newspapers and posted on the study website.
