- 5.1. **Downtown Strategy**
Mojan Jianfar, Planner & Project Lead, City Building Initiatives

Mojan Jianfar provided an overview on the Downtown Strategy. The purpose of the project is to prepare a strategy and action plan that will ensure the downtown meets the needs of its users. The strategy builds on the foundation of the Downtown21 Master Plan that outlined a vision to transform the downtown from a suburb to an urban area. The new strategy will be using the foundation of the Downtown21 to further improve and make the necessary adjustments to fit the ever-growing population. The project's timeline consists of five (5) phases; background, current state, defining the future, draft vision and direction and the downtown strategy. Each phase will involve engagement initiatives, such as online surveys, public workshops, focus groups, and open houses.

Members of the Committee spoke to the matter and raised the following questions and concerns;

- Inquired about potential strategies and interim solutions during the process of developing and revamping downtown
 - Such as, multi-use trails for accessibility and safe cycling being blocked due to construction;
- Green Lens; and
- Incorporating green space, tree shading, and storm water aspects.

Ms. Jianfar responded to the questions from the Members of the Committee;

- The ongoing construction that has created blockades has been a learning lesson. The City will be providing alternative routes during the implementation of projects.
- A green lens is a priority and the Energy Management department will be working with Environment regarding Climate Change and environmental trends.
- The current focus of the project is broader with future plans of identifying what the key priorities are. Suggested the members fill out the Downtown Strategy survey to help further identify areas that may need further environmental improvements.

5.2. Corporate Green Building Standard (Related to Item 7.1)
Sumeet Jhingan, Project Manager, Energy Management

Sumeet Jhingan provided an overview on the Corporate Green Building Standard. The current standard as of January 2010 for all new construction and renovation of City buildings are required to meet the LEED (Leadership in Energy and Environmental Design) Silver Standard for new builds over 10,000 square feet. The City is implementing their own advanced standard based off the trends in energy consumption and intensity. The four corporate perspectives that outline the need for a change towards a new standard are the City's Strategic Plan for a net-zero carbon, the Climate Change Action Plan to reduce 80% GHG (greenhouse gases) by 2050, the utility budget stability, and sustainable procurement. The City's approach to a new standard is to improve environmental performance, reduce operating and maintenance cost as well as Mississauga being a green leader. The new corporate standard continues to include the five overarching LEED silver requirements with additional conditions and a tier-based system. The benefits of the new standard would be increased productivity and staff retention, improved health and reduced sick days, improved resilience to extreme events and the creation of jobs. The Corporate Green Building Standard Roadmap is recommending that by 2020 every new build will be at level 1, level 2 by 2025 and level 3 by 2040.

Members of the Committee spoke to the matter and raised the following questions and concerns;

- Whether the operating savings cost has been incorporated;
- Inquired about incentives in-between the target dates and set levels;
- Inquired if existing buildings can reach a higher level;
- Inquired why this standard is not mandatory for all Mississauga builds;
- The number of upcoming builds;
- Inquired if the best practices and guidelines resources will be shared;
- Inquired how the new standard is tracked and achieved; and
- Inquired how the City plans to keep this standard in mind for future developers.

Mr. Sumeet Jhingan, Daniela Paraschiv, Manager, Energy Management, and Councillor Mahoney responded to the questions from the Members of the Committee;

- The costs saving regarding operation and maintenance have been incorporated.
- There are current financial incentives available; loans and grants from the FCM (Federation of Canadian Municipalities), such as the Green Municipal Fund.

- There is a possibility to revamp existing buildings to adhere to the new Corporate Green Building Standard, even though it is much easier to start with a clean state as existing buildings can present a number of challenges due to unforeseen aspects.
- The new standard is Corporate (The City of Mississauga) based only, however the City's intent is to lead by example before branching out to the private sector. The private sector is also governed by the Ontario Building Code and Planning Act, which are Provincial legislations that must be taken into consideration when implementing standards City wide to include the private sector.
- There are number of upcoming proposed buildings include community centres, fire stations and a couple of major renovations that will be adhering to the new standard.
- Any projects that set the standard as a best practice will be shared with other municipalities and then as a resource for the private sector developers.
- The implementation of the standard assists in monitoring and ensuring the standard is being met through meter systems being installed that provide verification.
- The City will be following the model that Toronto and Vancouver, BC use, which entails having a repository on their websites with the best leading examples to help with development plans and engineering.

Adopt-A-Park: Environmental Action Committee Participation

Keeping Mississauga
clean and free of litter
is a huge
task



What is being done to help prevent litter?

Waste containers are placed in strategic locations along roadsides and in parks including the most recent addition of dog waste containers in select parks.



Outreach staff attend various events encouraging residents to help keep the City clean & reduce waste by using reusable items.



The City's bylaw, the Debris and Anti-Littering By-Law 219-85, discourages litter with a penalty of enforcement.

Mississauga's 20-Minute Makeover, residents join in by picking a location and cleaning up litter for 20 minutes each spring.



We partnered with other communities across Canada in an initiative called Clean Canada Together which shares in key messaging and best practices around litter.



Is a community focused program with a formal process and commitment of 3 cleanups/year for 2 years. EAC Committee Members have agreed to support the program with their own park litter cleanups.

Metrics



On average, 2kg of litter is removed per participant per cleanup (based on results from Clean Canada Together data)

Environment Section's adopted park cleanup at Camilla Park included multiple volunteers who removed various bags of garbage and recycling (including: bike frame, and styrofoam cooler)

Next Steps

- Pujita Verma (EAC member) has volunteered to act as the administrative representative for the EAC Adopt-a-Park cleanup.
- She will coordinate with the group to review the location, coordinate dates for cleanups in 2020 and coordinate with parks prior to proposed dates for supplies (bags, gloves).


