Councillor Parrish enquired about including No U-turn signs at major intersections on the general entrance signs to the City. Geoff Wright, Commissioner, Transportation and Works advised that U-turns are permitted at major intersections, unless otherwise posted. He noted that he would look into the logistics of it from a legal perspective.
