#### 5. DEPUTATIONS

5.1 <u>Vikas Kholi, Executive Director and Lauren Pires, Project Management Lead,</u> <u>MonstrARTity regarding the 2019 Festival update and 2020 - 10th Anniversary</u> Bollywood Monster Mashup Festival at Celebration Square

Mr. Kholi spoke to the annual Festival; to success stories; statistics from previous years; investments in local artists; and noted that the Bollywood Monster Mashup was awarded 2019 "Festival of the Year" from the Mississauga Arts Council. Mr. Kholi spoke to the VIP reception taking place on July 9<sup>th</sup> to celebrate the 10<sup>th</sup> Anniversary of the Bollywood Monster Mashup Festival.

Ms. Pires spoke to the "Monster Arts for Youth" program, South Asian arts classes led by professional, world class artists for elementary, middle and secondary school students. Ms. Pires spoke to the many workshops, removing cultural barriers and noted the program was extended to seniors in 2018 through the "Monster Arts for Youth at heart" program.

Councillor Kovac spoke in support of the festival. In response to Councillor Kovac, Mr. Kholi advised the festival will be taking place from July 10<sup>th</sup> – July 11<sup>th</sup> and spoke to special presentations and new technology planned for the event.

Councillor Damerla spoke in support, enquired about the cultural standpoint of the programs. In response, Mr. Kholi spoke to ensuring inclusion by using "mashup" to mix communities altogether.

Mr. Duquette and Mr. Hancock spoke to the history of Legends Row; how it came to be; the inductees; the grand opening on June 3, 2017 at Mississauga Celebration Square; the partnership with Heritage Mississauga and the continued support of the Legends Row Legacy.

Councillors Ras, Starr, Saito, Dasko and Parrish spoke in support of the transfer of Legends Row to Heritage Mississauga and to the work done by Mr. Duquette as a volunteer for 50 years.

In response to Councillor Parrish, Mr. Duquette spoke to how to submit nominations online and noted the upcoming celebration of the 2018 class of inductees on February 15<sup>th</sup> and the 2019 inductees celebration at the year end.

#### 7. MATTERS CONSIDERED

### 7.1 <u>2020 Culture and Community Grant Programs</u>

Councillor Saito spoke to the Community Grants for Youth Program; multi-year grants and enquired about the application process and the eligibility criteria, specifically for the "Dam Youth" drop-in centres.

In response to Councillor Saito, Shari Lichterman, Acting Commissioner, Community Services spoke to the multi-year grant application process, noting it is based on 3 year cycle and open to all. Ms. Lichterman noted the smaller, \$10,000 grant is for a single program and further, the "Dam" could be eligible for multi-year funding if they apply. At the request of Councillor Saito, staff will review the application history of the "Dam" to determine if there is an opportunity to award the multi-year grant in 2020 and return to General Committee with a report.

Councillor Starr enquired about increasing the funding for the Egyptian Coptic Festival and approving funding for the Senior Tamil Society. Andrew Douglas, Grants Coordinator spoke to the required criteria and the rationale for the recommended funding.

Councillors Damerla and Saito spoke to the process and raised questions. In response, Sonia Banic, Manager, Culture Services spoke to the process, noting the intensive review conducted to arrive at the recommendations with great opportunity for support of the applicants. Ms. Lichterman spoke to the matter noting there is no further investigation required.

Councillor Ras spoke to accountability for awarding funding and noted a presentation of the grant application and decision process would be valuable in advance of the next report.

Members of the General Committee voted on a motion from Councillor Starr to increase funding for the Egyptian Coptic Festival by \$2,500.00. The motion failed.
