- 5.1. Cameron McCuaig, Resident regarding Inspire the World

Mr. McCuaig spoke to "Inspire the World" and noted that the City needs to take greater care in creating future heritage and that the City should have a goal of becoming a net zero carbon city.

Members of Council thanked Mr. McCuaig and made the following comments: that Council would need to consider branding the City as a zero carbon City; the need for Federal Government funding for private residents; engaging developers to move towards zero carbon development; the need for further discussion with the Economic Development Office and the Environment Office; an educational component of what net zero carbon is; the need to achieve change through the building code; and the need to continue work with the Environment Action Committee.

5.2. Item 8.1 Raymond Chan, CAA

Mr. Chan, CAA, spoke to the amendments to the City of Mississauga Tow Truck Licensing By-Law 521-04 and noted that CAA is not in support of the reducing the 7 year driving restriction to 5 years and recommended to repeal the 7-year G licence requirement entirely or reduce it lower than 5 years or allow the Manager of Mobile Licensing some discretion to approve an applicant's driving experience from another jurisdiction in combination with a valid G-license. Members of the Committee made the following comments: that CAA created a negative member engagement campaign that inundated Members of Council with emails; that members of the Towing Industry Advisory Committee support the amendments; the number of CAA tow incidents versus the number of mobile service assistance calls; the rationale behind CAA getting additional tow truck licenses; and that CAA is a valuable member to the Road Safety Advisory Committee.
