Mr. Malik suggested that more information on the Friends be made available on programs and at Museums events such as *Maple Magic*, at which hundreds of people attend, to promote awareness and increase membership. Ms. Coghlan thanked Mr. Malik and agreed that this was an opportunity to boost awareness of the Friends' in addition to their quarterly newsletter.

The Chair thanked Ms. Coghlan for her update and the efforts of the Friends.

#### 8.4. Vacancy on MOMAC

Ms. Alikhan advised that a vacancy has resulted on MOMAC from Jeremy Harvey's resignation. The Committee felt it was important that the vacancy be filled.

Councillor Ras noted that there were a number of candidates interviewed early in 2015 and a suitable replacement can be drawn from this pool. I. Malik felt that a member from the Aboriginal community be appointed. Ms. Alikhan advised that the Corporate Policy dictates that the City first draws from applications on file before advertising externally. She stated, however, that Committee Members are encouraged to contact interested people in the community to submit applications in the meantime.

Mr. Malik also expressed concern that there are members of MOMAC who remain consistently absent. Ms. Alikhan advised that the Council Procedures By-law dictates the rules regarding member absences and the Office of the City Clerk is responsible for ensuring the By-law is upheld when appropriate.

#### Time Traveller: New Perspectives on a Colonialist past and Neo-Colonialist Future

**Benares Visitor Centre** 

Skawennati - April 16th to June 26th 2016

How can we begin to understand the experience of others, especially those whose struggles have been omitted or inaccurately presented in colonial narratives? New-media artist Skawennati Tricia Fragnito of Mohawk and Italian descent work centers on forging space for First Nations peoples in the digital world. Along with a community of First Nations artists she questions colonialism and how to create a neo-colonialist future.

The nine part film series "Time Traveller" infiltrates the virtual space of Second Life and machinima, (video-game animation) to design a futuristic platform to both humanise a neglected First Nations peoples and alter the viewer's impressions of our shared history and the future of First Nations culture and nationhood.

Viewers will follow Hunter, a skilled bounty hunter from the year 2121, as he travels back in time with his virtual reality device TimeTraveller™ to historically significant events to First Nations Peoples, such as the Dakota Sioux Uprising, the Oka Crisis and the occupation of Alcatraz Island.

By combining an educational tone with a form of popular visual entertainment, the artist successfully engages her viewers in a complicated narrative and opens up a much needed dialogue about how history is written and the importance of making space to embrace multiple voices.

Born in Trinidad and Tobago, Morris Lum is a first-generation Canadian Chinese artist that is interested in photographing social spaces inhabited by the Chinese diaspora in the suburbs of the Greater Toronto Area, (GTA) Lum's body of work on the subject demonstrates to viewers how *place* can influence the way class, identity, belonging and belief systems take shape within a community.

The works themselves serve as both archival material, depicting the histories of the Chinese diaspora in the GTA and architectural documents. At the center of the works is the opportunity for the viewer to visually compare and contrast sites and spaces of similarity in their own life experience.

In the age of spiritual individuality, how has the role of sacred spaces evolved? These photographs show the interiors of places of worship in Mississauga and the GTA; some are formal religious spaces, others are make-shift spaces that are used for prayer and gatherings. The scenes are straightforward and journalistic in nature.

What is your sacred space? In some instances, the spaces photographed are not easily interpreted as sites of spiritual worship. This could address the limited availability of space for worship and the reuse / recycling of buildings within the GTA. Although, a more spiritual answer could be any site can become a site for worship, if a community or an individual choose the time and location.

Maple Magic including, March is Maple Magic Month, Maple Magic March Break Drop-In and Sap to Syrup Education Programming at the Bradley Museum generated great interest and feedback from across Mississauga.

The event included a sponsorship from Friends of the Museums of Mississauga, Port Credit Community Foundation and CRH. The Event ran for six Sundays from February 28<sup>th</sup> to April 3<sup>rd</sup> including the entire week of March Break from March 14<sup>th</sup> to 18<sup>th.</sup> Sap to Syrup Programming ran February 29<sup>th</sup> to April 12<sup>th</sup>. Expanded programming with partnerships developed during the Maple event component: Affair Rentals, Peel Aboriginal Network, Mississaugas of the New Credit First Nations, The Lumber Jack Show, Mississauga Arts Council, Meadowvale Theatre, Touch the Past, Ponies R Us, Mane Attraction, Beavertails Food Truck, Mississauga Forestry, 1 Million trees campaign, Settlement Services Agencies and local artisans.
