3.2. To permit 136 back to back stacked townhouse units and two, three storey commercial buildings

David Ferro, Development Planner, provided an overview of the application to permit 136 four storey back to back stacked townhouses and two three story commercial buildings.

Patrick J. Harrington, Legal Counsel spoke to the application and noted that the applicants preference is to work with staff on design considerations and avoid going to the OMB. He noted that the applicant had created a revised concept to address staffs design concerns and that a prehearing has not been set as the applicant would like to continue their dialogue with the City.

Councillor Ras spoke to the issues identified by staff and that the issues can be resolved.

The following residents made oral submissions expressing support of the proposed development and enquired about proposed timelines for approval and construction.

The following residents made oral submissions citing concerns with the proposed development. The following concerns were discussed: safety concerns with the proximity to the train tracks and Clarkson Road; losing heritage significance of the area; increased traffic; the future of railway tracks going underground or a bridge over the railway tracks; and Metrolinx setbacks. Lesley Pavan, Director, Development & Design Division responded to concerns.

Councillor Ras thanked members of the public for attending and encouraged staff and the applicant to continue discussions and enquired if a draft settlement could be shared with residents. Ms. Pavan spoke to a draft settlement and agreed to bring it to the community if time permits. Michal Minkowski, Legal Services spoke to the process of mediation and the confidentiality of agreements.

 not represent good planning and should be refused.

That City Council provide the Planning and Building Department the authority to instruct the City Solicitor on modifications to the position as may be deemed necessary during or before the OMB hearing process; however, if there is a potential for settlement, then a report shall be brought back to Council by the City Solicitor.
