4.7. PUBLIC MEETING INFORMATION REPORT (WARD 5)

MyMalton - Implementing Mississauga Official Plan Amendment and Zoning for the Malton Neighbourhood Character Area and Great Punjab Business Centre

The following persons spoke:

- 1. Mr. Charanjit Dhir, Resident expressed concerns with the traffic congestion in the area, and the volume of tractor trailer driving schools in the area.
- 2. Mr. Mark Bradley, Glen Schnarr & Associates, raised concerns regarding the proposed cap to permitted uses under the current Zoning By-law and noted that current permitted uses should not be included in the 50% cap.

Councillor Parrish advised that she raised the issue at Council regarding tractor trailer training driving schools in the area and that staff will be reporting back to Council on the matter. Councillor Parrish spoke in support of staff's recommendation regarding the City's initiated Zoning By-law amendments.

Ms. Paulina Mikicich, Manager, Planning Innovations, spoke regarding the challenges regarding permitted uses and the 50% cap, and advised that she would be happy to have discussions with the Owner regarding this matter. Ms. Mikicich, noted that the Region of Peel is in agreement with the proposed amendments, and that any further amendments would have to be considered by the Region.

In response to Councillor Fonseca's inquiry regarding the operation of the community centre, Mr. MacFarlane advised the Community Centre and Religious Assembly will only operate within specified times.

Staff provided responses to Councillor Fonseca's inquiries regarding parking, traffic studies and security, as follows:

Marianne Cassin, Manager, Development Central advised that there is no change to the parking standards.

Jeremy Blair, Manager, Transportation, Infrastructure Management, advised that a traffic impact study has been requested and will be included in the next report. Mr. Blair further advised that staff will address any issues with the Owners.

Councillor Fonseca noted that it has been brought to her attention that individuals are trespassing through the Montessori School property and requested that the Applicant and staff address the fencing issues.

The following person spoke:

1. Martine Piranio, Resident, spoke in opposition of the application, expressing concern of over building, high density and volume of traffic along Eglinton Avenue, and inquired why there is so many buildings being built.

Mr. Andrew Whittemore, Commissioner, Planning and Building explained that the Province designates the growth down to the Municipality, and that the City reviews the area in which to apply the growth.

In response to Councillor Fonseca's inquiry regarding the comments noted on page 25, Appendix 1 regarding the impacts of the floodplain area, Mr. Jonathan Famme, Planner, noted that the applicant advised that they have conducted a survey of the as built conditions on-site to identify the impact and where they encroach, and that it has been forwarded to the Toronto Regional Conservation Authority.

Councillor Fonseca requested to be included in meetings between staff, the applicant and the TRCA.
