- 6. <u>DEPUTATIONS</u>
- 6.1 <u>Donald (Murrary) Scott, Resident regarding letters received from by the Road Safety</u> <u>Committee on February 5, 2019</u>

Mr. Scott spoke to his experiences in Mississauga over 40 years; the evolution of the City; road safety concerns; enforcement of rules of the road; misuse of accessible parking permits and suggested possible solutions.

Councillor Saito spoke to accessible parking enforcement across the City. Acting Inspector Greg Amoroso, Peel Regional Police spoke to allocating resources; prioritizing calls; streamlining in targeted areas based on statistics, noting a reduction in traffic tickets and a future campaign to address respectful road sharing. Acting Inspector Amoroso noted that enforcement locations are determined based on higher volume of accidents rather than radar patrol. Sergeant Sean Cole, OPP spoke to their similar practice of using statistics to prioritize calls.

Members of the Committee engaged in a discussion with respect to Mr. Scott's comments and noise ticketing; road markings and road conflict. Acting Inspector Amoroso spoke to the current program in place to prevent street racing. Councillor Saito spoke to a review underway through the Accessibility Advisory Committee regarding concerns over illegal use of Accessible Parking permits and an upcoming Automated Traffic System pilot program

John Walmark spoke to lighting concerns and road markings causes conflict on the roads. Councillor Saito spoke to these concerns being addressed in the Vision Zero strategy.

#### 8. MATTERS CONSIDERED

#### 8.1 <u>2019 Region of Peel Vision Zero Road Safety Strategic Plan Update</u>

Matthew Aymar, Analyst, Research and Policy Region of Peel Public Health spoke to the report and provided a summary with respect to the overview of countermeasures; statistics from the year; priorities; planning initiatives for 2020. Mr. Aymar spoke to the development of a Fatal Collision Review Committee with the Region of Peel, Peel Public Health Unit and the Peel Regional Police Major Collision Bureau noting the first meeting to take place on February 7, 2020. Mr. Aymar spoke to the Quarter Audit of Public Works, looking at specific intersections to address safety as well as internally doing gap analysis to determine what is required by staff to implement Vision Zero.

#### 8.2 <u>Budget Discussion: Distracted Driving and Pedestrian Safety Campaigns, Kimberly</u> <u>Hicks, Senior Communications Advisor, Communications</u>

Ms. Hicks presented the Distracted Driving Campaign, paid advertising concepts providing the Committee with statistics, a cost breakdown; targeted age rage (17-35 male); a social media kick-off event and next steps. Ms. Hicks noted once the plan is approved, Creative Services can begin to develop the social media advertisements.

Councillor Ras and Sunil Sharma, Citizen Member spoke to necessity develop "edgy" advertisements to draw the attention of the target group; hosting the kick-off event at a local high school and educating the passengers of the target groups. Councillor Saito suggested seeking input on advertisements from Sheridan College students.

Members of the Committee engaged in a discussion with respect to coordinating Campaigns with the Region of Peel during Distract Driving Month; partnering with Sheridan College; developing a video; utilizing available resources to broadcast messages such as technology companies; insurance companies and overpass signs. Councillor Dasko spoke to the disregard of youth for penalties.

The Road Safety Promotional Subcommittee was directed work with Ms. Hicks to develop the Distracted Driving Campaign and report to the Road Safety Committee in February.

#### 8.4 Mid Block Crossing

Councillor Saito spoke to the original concerns of mid-block crossing and noted this is being address by the Vision Zero strategy. Sunil Sharma, Citizen Member spoke to investigating barricade placements to prevent mid-block crossing. Councillor Saito responded noting this has been suggested in the past and noting that it could pose further danger.

#### 8.5 Implementation of the 40km speed limits: Update

Colin Patterson, Supervisor, Road Safety provided an update on the matter noting Council approved the budget to complete the project by the end of 2020.

#### 8.3 Intersection Lane Markings

Councillor Saito addressed concerns about the distance between the painted stop bar at intersections and the pedestrian crosswalk and requested that staff and the Region of Peel look at moving stop bars to create a larger space between the marking and the pedestrian crossing. Colin Patterson, Supervisor, Road Safety and Seema Ansari, Technical Analyst, Traffic Safety, Region of Peel spoke to matter and will report back to the committee on findings at a later date.

In response to Tony Power, Citizen Member and Vice Chair, Mr. Patterson noted staff are working on documenting the before and after areas that have undergone traffic calming and Vision Zero.

#### 9.1 "Sounds of Texting": OPP Distracted Driving Video.

Members of the Committee viewed the OPP Distracted Driving Video. Acting Inspector Greg Amoroso spoke to the Peel Regional Police Video also available on their website.

Sergeant Sean Cole spoke to the statistics provided noting they include Milton, Brampton and Mississauga, the entire detachment in Port Credit. Sergeant Cole spoke to the decrease in careless driving charges and changes in collision reporting.

Dear Mayor Crombie,

I'm sending this email to you personally to share my opinion regarding pedestrian casualties in our city and how we can possibly prevent it.

Statistics shows that pedestrian fatalities have increased year over year not only in our city but in the Greater Toronto area as well. Guidelines and stiffer penalties are imposed on drivers found guilty of hitting a pedestrian, resulting in serious injury or death. I will never condone nor justify drivers who have the illusion that driving under the influence is alright, disregarding speed limits, unsafe vehicles, stunt driving and speeding on city streets. These are all unacceptable.

I live in Mississauga for many years and have seen the city grow. Like most Missisaugans, my daughter commutes to Toronto to work and walk the streets everyday. My wife and I have this constant fear, like every concerned parent that some unmindful driver may cause her harm. Because of this I taught her how to be a "DEFENSIVE PEDESTRIAN" and be aware all the time.

Technological advancements have changed our lives. We always need to be "connected", both drivers and pedestrians. Modern vehicles are moving computers equipped with sophisticated sensors and multiple cameras that detect objects and react milliseconds faster than the human brain. What these computer can not do is read the mind of a person crossing or just walking a street, oblivious of their environment.

#### My solution: PEDESTRIAN EDUCATION PROGRAM

Here are some awarenes tips that could possibly save lives:

- Use of earphones reduces street sound
- Wearing a hoodie reduces peripheral view
- Always walk facing traffic
- Make eye contact with the driver before crossing a street

- Avoid being in a vehicle's "blind spot". You are invisible to the driver. If you can not see the driver on the side mirrors of the vehicle, the driver cannot see you

- Wear a reflective arm band when it's dark
- Avoid wearing dark clothing, especially when it's dark (use reflective vests)
- Use designated pedestrian lanes, do not j-walk
- Always follow the pedestrian walk lights
- Never insist on your right of way
- Stop, Look and Listen
- Avoid texting while walking
- Avoid using cellphones while walking
- Alcohol, drugs and some over the counter medications could reduce sensory perception

Cities spent so much resources trying to minimize, if not prevent pedestrian casualties. Let us step back and rethink this. Maybe we should also EDUCATE PEDESTRIANS by promoting awareness programs on how to protect themseves.

I remember years ago, when I use to walk our children to trick-or-treat in the nieghbourhood, we would get this reflective arm bands from Rogers for free. Why can't the city bring back a program like this for regular pedestrians?

Commercials both on the radio and television are all over, warning drivers to be careful. But, I've never seen one that advises pedestrians how to be safe.

Let us be mindful of each other. Together we can save lives and enjoy the streets of our city together.

# Q1. What must I provide when I submit a nomination?

### A1. Each nomination must include:

- a completed nomination form
- a nomination letter that is at least one page in length (approximately 3,000 to 4,000 characters)
- **a minimum of** two letters of support written and signed by two separate individuals

The nomination letter must outline the individual, group or initiative's accomplishments, highlighting examples of leadership, dedication and commitment in the field of road safety during **2019**. All fields within the nomination form must be completed. Nomination forms that are incomplete will not be accepted.

# Q2. What should be included in the letters of support for each nomination?

A2. Letters of support must clearly indicate who submitted the original nomination (the nominator) and who is being nominated (the nominee). Each nomination must include a <u>minimum</u> of two letters of support written and signed by two separate individuals. Letters of support should recognize the accomplishments of the nominee that are different from that of the nominator.

# Q3. Can I nominate the same individual or team in more than one category?

A3. No, the nominator must choose one category for their submission.

# Q4. Can more than one person nominate the same individual or team for an award? Will this increase their chance of receiving an award?

A4. More than one person can submit a nomination for the same individual or team. It strengthens a nomination to have more than one nominator, particularly if the nominators can provide a different perspective on the nominee's work.

# Q5. How are award recipients selected?

A5. Each year, the Road Safety Marketing Office establishes a selection committee that is diverse and broadly represents the road safety and injury prevention sectors. The committee reviews all of the nominations by category and evaluates them based on how well they meet the criteria.

The selection committee will make its final selections in May 2020. The decisions of the selection committee are final.

# Q6. When will the awards ceremony be held?

A6. The details of the awards ceremony will be made available when the award recipients are announced. The awards ceremony will be held in the Greater Toronto Area in June 2020 (TBC).

# Q7. How will I know if my nominee is selected?
