3. PRESENTATIONS / DEPUTATIONS

3.1 Colin Patterson, Supervisor, Road Safety, provided an overview of the Pedestrian Crossover Pilot Project, as well as provided a brief summary on the new regulation (402/15) under the *Highway Traffic Act*. Mr. Patterson explained that a “pedestrian crossover” means any portion of a roadway distinctly indicated for a pedestrian crossing by signs on the highway and lines or other markings on the surface of the roadway as prescribed by the regulations. Mr. Patterson further added that Pedestrian Crossovers in some cases, but not always, may also have pedestrian-activated flashing lights. Members of the committee engaged in discussion regarding pedestrian crossovers and made the following comments and inquiries: are there roadway markings before a pedestrian crossover to indicate where a vehicle stops; is it intended for pedestrian crossovers to replace crossing guards; feedback from other Municipalities; what are the costs associated with the implementation of pedestrian crossovers; who determines the location for the implementation of a pedestrian crossover, and how does one submit a request for a location to be considered.

Mr. Patterson thanked the Members for their feedback and encouraged Members to read through the Corporate Report included in the Traffic Safety Council Agenda for further information, or to contact him should they have any further questions or comments. Also, Mr. Patterson requested Angie Melo, Legislative Coordinator to email the PowerPoint presentation to the Members, as the images in the handout were not very clear.
