- 3.1. <u>Pina DiMartino, with respect to school walking route to St. Valentine Catholic Elementary</u> <u>School.</u>

Ms. DiMartino spoke to the closure of St. Gertrude Catholic Elementary School, and the placement of students at St. Valentine Catholic Elementary School. Ms. DiMartino provided a slide presentation of photographs she took at the intersection of Mavis Road at Lafayette Drive/Preston Manor Drive, noting that there is a high volume of heavy trucks travelling in this area. Ms. DiMartino further spoke to her observations at the time Traffic Safety Council Members where conducting the site inspection, noting that the information on the site inspection report was lacking data, and/or that there was data omitted on the report that had been observed by Ms. DiMartino. Ms. DiMartino requested that Traffic Safety Council not pass the recommendations as listed on the agenda, and that the intersection be deemed unsafe for children crossing the intersection to attend St. Valentine Catholic Elementary School.

Peter Westbrook, Chair, thanked Ms. DiMartino for her deputation.

RECOMMENDATION

That the deputation by Pina DiMartino with respect to school walking route to St. Valentine Catholic Elementary School be received.

<u>Received</u> (T. Coulson) Recommendation – TSC-0105-2017

3.2. <u>Tina Chiappette, with respect to school walking route to St. Valentine Catholic</u> <u>Elementary School.</u>

Ms. Chiappette, expressed her concerns with children ages 9 to 12 crossing an arterial road where she has observed that vehicles are traveling at higher speeds than posted, and that there is a high volume of heavy trucks in the area. Ms. Chiappetti, also noted that she attended the intersection at the same time Traffic Safety Council ("TSC") was conducting their site inspection, and commented on the discrepancies between the notes found on the TSC's site inspection report and the notes that she took. Ms. Chiappette further expressed her frustration with the lack of communication between Student Transportation of Peel Region, the Dufferin-Peel Catholic District School Board and TSC. Ms. Chiappette, requested that TSC deem the intersection unsafe.

Mr. Peter Westbrook, Chair, thanked Ms. Chiappette for her deputation.

RECOMMENDATION

That the deputation by Tina Chiappette with respect to school walking route to St. Valentine Catholic Elementary School be received.

5.2. Site Inspection Report - St. Valentine Catholic Elementary School (Ward 6)

Site Inspection Report for the safety review conducted on September 12, 2017 at the intersection of Mavis Road and Lafayette/Preston Manor Drive for the students attending St. Valentine Catholic Elementary School.

Members engaged in discussion regarding their observations of the traffic concerns on Mavis Road, noting that this is an arterial road with a posted speed of 70KM and with many heavy trucks in the area.

Members who attended the site inspection provided an overview of their observations, noting that they did not observe any issues with turning traffic and that motorists were courteous to crossing pedestrians, students crossing at the intersection crossed in groups safely; however, it was observed that students crossing in the afternoon were distracted while crossing the road by bouncing balls, riding their scooter, while other students were observed running across the road.

Councillor Sue McFadden spoke to the role of Traffic Safety Council ("TSC") in circumstances of school closures, stating that the committee needs to work with the Board to ensure that students travel to school safely. Councillor McFadden moved a Motion that TSC deem the intersection of Mavis Road at Lafayette Drive/Preston Manor Drive, for the students attending St. Valentine Catholic Elementary School, unsafe. Members voted on the Motion; the Motion failed.

Thomas Thomas, Dufferin-Peel Catholic District School Board spoke to this matter and advised that the position of the school board is that if TSC deems the intersection unsafe, the matter will then be reviewed by the school board and student transportation.

Brad Butt, Citizen Member, noted that Traffic Safety Council needs to continue to monitor this location, by conducting further site inspections, specifically, when Transportation and Works advises that the pedestrian phase is set at a slow walking speed and that the zebra markings have been painted on all four legs of the intersection. Mr. Butt requested that a further site inspection be added to the Recommendation. Also, Members discussed the benefits of having a red light camera installed at this intersection and requested that a recommendation to request staff to review the feasibility of installing a red light camera at this intersection, be added the Recommendation.

RECOMMENATION

- 1. That Transportation and Works be requested to:
 - a. Paint zebra markings on all four legs of the intersection of Mavis Road and Lafayette Drive/Preston Manor Drive for the students attending St. Valentine Catholic Elementary School.
 - b. Review the traffic signals at the intersection of Mavis Road and Lafayette Drive/Preston Manor Drive to ensure that the pedestrian phase is set at a slow walking speed for the students attending St. Valentine Catholic Elementary School.
- 2. That the Principal of St. Valentine Catholic Elementary School be requested to continue to remind students of the following:
 - a. To dismount from their bike and/or scooter before crossing the roadway
 - b. To not run across the road
 - c. To not bounce balls while crossing the roadway

- That Traffic Safety Council conduct a further site inspection at the intersection of Mavis Road and Lafayette Drive/Preston Manor Drive, for the students attending St. Valentine Catholic Elementary School, once recommendations 1 through 2 have been completed.
- 4. That Transportation and Works staff be requested to review the feasibility of installing a red light camera at the intersection of Mavis Road and Lafayette Drive/Preston Manor Drive, for the students attending St. Valentine Catholic Elementary School.





Dear Chair Peter Westbrook and the Members of the Traffic Safety Committee,

On behalf of my constituents, whose children have been moved from St. Gertrude's to St. Valentine Catholic Elementary School, I moved a motion at Council on Wednesday October 4, 2017 to declare the intersection of Mavis/Lafayette/Preston Manor UNSAFE. It was supported unanimously by my colleauges.

I am shocked that the review of a roadway with a posted 70km/hr speed, an official truck route and a record of recent road fatalities – would recommend "zebra markings, the pedestrian phase of the lights be set at a slow walking speed and children be reminded not to bounce balls, run or ride scooters." Ludicrous!

The Traffic Safety Act correctly restricts the placement of a crossing guard on a roadway if the speeds on that roadway exceed 60km/hr because "you cannot have an (adult) human being controlling traffic exceeding 60km/hr." And yet, in its wisdom, the Committee felt twelve-year-olds could dodge those running red lights, traffic making turns in all directions and recent sidewalk repairs that closed portions of the sidewalk and forced children onto the roadway.

All the Councillors and Trustees on the TSC voted to declare the crossing unsafe, yet many citizen reps voted against that motion! A vote is a solemn trust as is the safety of children for which we are all responsible. I sincerely suggest those who voted for zebra stripes reconsider their function on this committee. It is not saving taxpayers' dollars, it's saving children's lives!

Closing St. Gertrude's was traumatic for the community. Losing one of its children would be unbearable.
