Site Inspection Report for the safety review conducted on November 7, 2019 at the intersection of Lisgar Drive, Allcroft Road and Dillingwood Drive for the students attending Lisgar Middle School.

RECOMMENDATION

Camille McKay, Manager, Parking Enforcement advised that Parking Enforcement staff had visited the school 10 times in October and they had given 9 tickets. Both Robert Crocker, Peel District School Board Trustee and Sheelagh Duffin, Supervisor, Crossing Guards were advised to contact the Principal in regards to the committee's concerns with the removal of the school's Kiss and Ride.

RECOMMENDATION

1. That Transportation and Works be requested to review all the signage on Ceremonial Drive in the school zone and on Esprit Crescent and sign "No Stopping" opposite Champlain Trail Public School on Ceremonial Drive.
2. That the Principal of Champlain Trail Public School be encouraged to work with the Peel Board of Education to re-open the Kiss and Ride to help alleviate the dangerous situation on the street with parents dropping off and picking up unsafely and blocking through travel lanes thereby blocking access for emergency vehicles.

- THE PRINCIPAL ADVISES CUSTODIAN CLOSES THE GATE BETWEEN 5:30 - 6:00 PM EACH DAY.
- VEHICLES THAT USE THE GATE ARE SCHOOL RELATED STAFF, SCHOOL BUSES, FEW PARENTS. THERE IS SIGNAGE THAT REFERS TO "STAFF USE ONLY". NO EVIDENCE THE HALF HOUR BEFORE SCHOOL ENTRY AND THE HALF HOUR AT SCHOOL DISMISSAL THAT THE GATE AND RUTLEDGE ROAD ARE BEING USED AS A PUBLIC THOROUGHFARE TO ACCESS BRITANNIA ROAD AND VICE VERSA.
- KISS AND RIDE AT FRONT OF THE SCHOOL NOT PAINTED WITH DIRECTIONAL SIGNAGE.

Recommendations

- 1) THAT THE PEEL DISTRICT SCHOOL BOARD BE REQUESTED TO PAINT AND SIGN THE KISS AND RIDE AS PER STANDARD IN FRONT OF DOLPHIN SENIOR PUBLIC SCHOOL.
