## 5. **DEPUTATIONS**

5.1. Michelle Berquist, Project Leader, Transportation Planning spoke regarding "Mississauga Moves", the Transportation Master Plan.

Ms. Berquist provided an extensive overview of Mississauga Moves the Transportation Master Plan, highlighting connections to the City's Strategic Plan, progress on the development of the Plan, and spoke to next steps. Furthermore, Ms. Berquist provided clarification regarding the study's methodology, indicated that there was no plan to allow taxis to utilize the Transitway and noted the value of input provided by the taxi industry.

5.2. Michael Foley, Manager, Mobile Licensing Enforcement provided a presentation with respect to the Accessible On-Demand Vehicle for Hire Project.

Mr. Foley provided an in-depth overview of the project, noting the project charter and market analysis to date, information regarding a jurisdictional scan including market factors and funding, courses of action, stakeholder consultations and the project timelines. Furthermore, Mr. Foley spoke to the determination of the number of people

who would require the service and noted the goal to provide on-demand services was equivalent to 15 accessible taxis in the City. In response to questions from the members, Mr. Foley spoke to the timing of the project and next steps regarding consultation and analysis.

5.3. Michael Foley, Manager, Mobile Licensing Enforcement provided a verbal update with respect to the TNC Pilot Project.

Mr. Foley provided a general update on this matter and spoke to the current status of the project, noting that auditing had commenced on both Uber and Lyft and further noted that both companies had been compliant with reporting to date. Al Cormier, Citizen Member inquired whether the majority of TNC trips were considered as new business, to which Mr. Foley noted that statistically, the results appeared as such but that the accuracy of the data pertaining to new business specifically was difficult to assess. Baljit Singh Pandori, Taxicab Brokerages Representative inquired about the number of trips acquired by TNCs, to which Mr. Foley advised that the City is unable to divulge data pertaining to specific services. Furthermore, Mr. Foley noted that it was projected that the study would be completed on time.

5.4. Tejinder Singh Gill, Taxi Industry spoke regarding his written submission, being a request to amend By-law 420-04, as amended, to eliminate the maximum number of taxi plates that a plate owner can possess.

Mr. Singh Gill requested that the current Public Vehicle Licensing By-law 420-04, as amended be further amended to remove the maximum taxi plate limitation. Michael Foley, Manager, Mobile Licensing Enforcement indicated that M. Singh Gill's request would be considered within the TNC Pilot Project final report.
