Council has amended the Sign By-law and Portable Signs on Road Allowances Corporate Policy to provide additional advertising opportunities for businesses and community groups during the COVID-19 pandemic.

- \circ $\;$ Three additional portable signs per street front are added without a permit
- \circ $\;$ The maximum display period was extended from 21 days to 30 days $\;$
- \circ The number of permits per group was increased from 10 to 15 per year

2. Government of Canada support

 Canada Emergency Response Benefit (CERB) – Government of Canada https://www.canada.ca/en/services/benefits/ei/cerb-application.html Temporary income support for individuals forced to stop work because of COVID-19. The CERB currently provides \$500 a week for up to 16 weeks.

The Benefit is available to workers:

- Residing in Canada, who are at least 15 years old
- Who have stopped working because of reasons related to COVID-19 or are eligible for Employment Insurance regular or sickness benefits or have exhausted their Employment

Insurance regular benefits or Employment Insurance fishing benefits between December 29, 2019 and October 3, 2020

- Who had employment and/or self-employment income of at least \$5,000 in 2019 or in the 12 months prior to the date of their application
- Who have not quit their job voluntarily

An important clarification on artist earnings and royalties: On April 15, Minister of Canadian Heritage Steven Guilbeault confirmed that artists who are earning less than \$1,000 a month through their sources of income can still qualify for the CERB. The Minister also clarified that royalty payments are not included as a source of income, which means that royalties can be earned without penalty or loss of eligibility for the CERB.

Canada Emergency Commercial Rent Assistance (CECRA) – Government of Canada

The federal government has partnered with provinces and territories to deliver commercial rent assistance for small businesses.

- Forgivable loans to qualifying commercial property owners to cover 50% of three monthly rent payments that are payable by eligible small business tenants experiencing financial hardship during April, May, and June
- Loans will be forgiven if the mortgaged property owner agrees to reduce the eligible small business tenants' rent by at least 75% for the three corresponding months under a rent forgiveness agreement, which will include a term not to evict the tenant while the agreement is in place. The small business tenant would cover the remainder, up to 25 per cent of the rent
- Impacted small business tenants are businesses paying less than \$50,000 per month in rent and who have temporarily ceased operations or have experienced at least a 70 per cent drop in pre-COVID-19 revenues. This support will also be available to non-profit and charitable organizations, an important distinction for some arts and culture groups

Canada Emergency Business Account (CEBA) – Government of Canada <u>https://ceba-cuec.ca/</u>

The Government of Canada has launched the new Canada Emergency Business Account to ensure small businesses have access to the capital they need to see them through the current challenges.

- \circ $\;$ Implemented by financial institutions in cooperation with Export Development Canada
- \$25 billion program provides interest-free loans of up to \$40,000 to small businesses and not-for-profits
- Repaying the balance of the loan on or before December 31, 2022 will result in loan forgiveness of 25 percent (up to \$10,000)

• Canada Emergency Wage Subsidy (CEWS) – Government of Canada

- Generally covers 75% of an employee's wages up to \$847 per week for employers of all sizes and across all sectors who have suffered a drop in gross revenues of at least 15% in March, and 30% in April and May
- Will be in place for a 12-week period, from March 15 to June 6, 2020

- \$500 million emergency support fund to meet the financial needs of cultural, heritage and sport organizations facing significant losses due to COVID-19
- o It will be administered by Canadian Heritage with the support of its partners
- Objective is to have the funds available as quickly as possible
- On an April 23 tele-town hall, Lisa MacLeod (Ontario Minister of Heritage, Sport, Tourism and Culture Industries) indicated that she has requested that 40% of the Fund be invested in Ontario because of our high concentration of arts and culture industries
