

Thank you for applying to become a Busker for the 2020 season and congratulations on your successful application to the Program! Only 25 SaugaBusk permits will be issued for the 2020 shortened Busking season.

With guidance from Peel Public Health and adhere to provincial guidelines related to preventing the spread of COVID-19, the City of Mississauga has made the difficult decision to further cancel all festivals, events and large gatherings, until September 7, 2020.

The City of Mississauga has entered 'Phase 3' in the COVID 19 Pandemic and the modified Sauga Busks program is now available with a start date of August 14, 2020 and is open until October 31, 2020 daily between 11 am - 9 pm.

**\*\*In accordance to Ontario Regulation 364/20. \*\*\*\*Singers and players of brass or wind instruments must be separated from any spectators by plexiglass or some other impermeable barrier. Every performer and other person who provides work for the business or place must maintain a physical distance of at least two metres from every other person, except, if it is necessary for the performers to be closer to each other for the purposes of the performance or rehearsal,**

**You must:**

1. Print and sign your 2020 Terms and Conditions agreement and Code of Conduct (attached)
2. Bring both documents to the Customer Service Centre
  - a. The Customer Service Centre located at 5600 Rose Cherry Place, Mississauga, ON L4Z 4B6 – Paramount Fine Food Centre – Sports Zone - [www.paramountfinefoodscentre.com](http://www.paramountfinefoodscentre.com)
  - b. The office is open Monday thru Friday 8:30 am – 4:30 pm.
  - c. Participants under 18 MUST have their parents/Guardian sign the Terms and Conditions agreement before submitting.
  - d. Identifications are only available at the Paramount Customer Service office and cannot be picked up at City of Mississauga facilities.
3. Purchase insurance from the City of Mississauga at the cost of \$35.00 plus tax
4. If you have your own insurance coverage,
  - a. Bring a hard copy of the document.
  - b. It must name the City of Mississauga as an additional insured for 2 Million liabilities.
5. Obtain your Lanyard and photo Identification
  - a. Each permit can be used for up to five(5) people to accommodate groups- permit holder must be on site at all times

**Start Busking!!!**

- Busking identification must be worn at all time while you are performing.
- There is no electricity available or stages for performers – battery operated amps are acceptable to use

- Busking locations are not scheduled and are on a first come first serve basis with a 2 hour limit.
- Decals will not be installed in 2020.
- Alternative signage is installed at the approved SaugaBusks locations (maps attached)
- Specific marked locations and regulations regarding COVID protocols must be adhered to.
